It's important to safeguard and nurture what little of those linkages we have left.

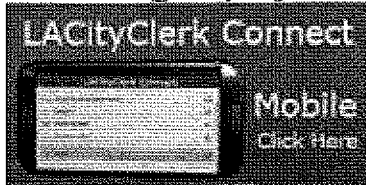

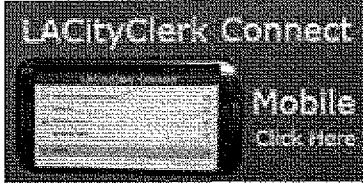

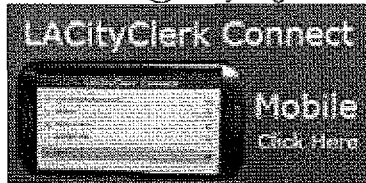
Dear Councilmembers Huizar and members of the plum Committee,
