PLANNING AND LAND USE MANAGEMENT COMMITTEE REPORT and RESOLUTION relative to a correction of land use designation for property located at Isabel Street and Isabel Drive.

Recommendations for Council action:

1. ADOPT the FINDINGS of the Los Angeles City Planning Commission (LACPC) and the Director of Planning as the Findings of the Council.
2. ADOPT the accompanying RESOLUTION, approved by the Mayor, the Director of Planning on the behalf of the LACPC, APPROVING the proposed General Plan amendment to correct the land use designation for Isabel Street from Collector to Local and for Isabel Drive from Local to Collector, in the Northeast Los Angeles Community Plan.
3. INSTRUCT the Department of City Planning (DCP) to update the General Plan and appropriate maps pursuant to this action.


Summary:

**RESOLUTION**

**WHEREAS** the subject streets, Isabel Street and Isabel Drive, are located within the Northeast Los Angeles Community Plan, updated by the City Council in June, 1999; and

**WHEREAS**, the Generalized Circulation Map illustrates the alignment of Isabel Street incorrectly; and

**WHEREAS**, Isabel Street is designated as a future connector but no right of way exist; and

**WHEREAS**, there is no plan to acquire right of way along the future segment; and

**WHEREAS**, the Isabel Street segment is not important to the overall street network; and

**WHEREAS**, the designation was based on faulty assumptions about capital improvements; and

**WHEREAS**, Isabel Street is a dead end street that is functioning as a local rather than a collector street; and

**WHEREAS**, Isabel Drive does serve as an important connector between other collector streets; and

**WHEREAS**, pursuant to the provisions of City Charter and the Mayor and the City Planning Commission have transmitted their recommendations; and

**WHEREAS** the requested General Plan Amendment is consistent with the intent and purposes of the Northeast Los Angeles Community Plan to designate streets in an orderly and unified matter; and

**NOW THEREFORE, BE IT RESOLVED** that the Northeast Los Angeles Community Plan be amended as shown on the General Plan Amendment Map.
