Honorable Chair and Committee Members:

For nearly four years, the Los Feliz Neighborhood Council (LFNC) has supported the current plan to construct two youth baseball fields in the Crystal Springs area of Griffith Park. We are tasked by the City Charter to assist in the delivery of city services, and we have long held this project to be a vital city service, sorely lacking and direly needed by our community.

The plan has now been reviewed and approved by:

A Regional Neighborhood Oversight Committee (RVNOC)  
A Local Neighborhood Oversight Committee (LVNOC)  
The Department of Recreation and Parks Board of Commissioners (RAPCOM)

Additionally, at significant cost, the plan has received a full Environmental Impact Report (EIR) under the California Environmental Quality Act (CEQA) guidelines, which was accepted and approved by RAPCOM. Further, six neighborhood councils near Griffith Park representing over 200,000 resident stakeholders unanimously resolved support for the Crystal Springs plan.

Comments from the public on matters not appearing on this Agenda within the Board's subject matter jurisdiction are heard during the Public Comment period, limited to 2 minutes per speaker, unless waived by the Board's presiding officer.

PROCESS FOR RECONSIDERATION: The Board may reconsider and amend its action on items listed here if that reconsideration takes place immediately following the original action, or at the next regular meeting. The Board, on either of these two days, shall: 1) Make a Motion for reconsideration and, if approved, 2) hear the matter and take an action. If the motion to reconsider an action is to be scheduled at the next meeting following the original action, then two items shall be placed on the agenda for that meeting: 1) A Motion for Reconsideration on the described matter and 2) a [Proposed] Action should the motion to reconsider be approved. A motion for reconsideration can only be made by a Board member who has previously voted on the prevailing side of the original action taken. If a motion for reconsideration is not made on the date the action was taken, then a Board member on the prevailing side of the action must submit a memorandum to the Secretary identifying the matter to be reconsidered and a brief description of the reason(s) for requesting reconsideration at the next regular meeting. The aforesaid shall all be in compliance with the Ralph M. Brown Act governing public entities.
