

PUBLIC SAFETY COMMITTEE REPORT relative to an Los Angeles Fire Department (LAFD) Fiscal Year 2014-15 Interim Budget Request.

Recommendations for Council action, SUBJECT TO THE APPROVAL OF THE MAYOR:

### SUMMARY

In the October 14, 2014 report to Council, LAFD requests additional funding in the amount of \$4.1 million in order to meet desired goals of enhanced service. The report lists the positions needed as well as other expenses for equipment, overtime, and space build-outs. The Department recommends that Council instruct the CAO to identify the funds needed for its requests.

At its meeting held October 24, 2014, the Public Safety Committee discussed this matter with the Fire Chief. The Chief stated that \$4.1 million will cover the requested staff and program

expenses for six months. Committee members went on to discuss the need to restore service to certain areas of the City to which emergency fire response can be impacted by ongoing street construction, traffic patterns, and topography. The Committee recommended that Council approve LAFD's report instructing the CAO to identify a source of funding for the Department's \$4.1 million interim budget request and the position authorities.
