MITIGATED NEGATIVE DECLARATION and PLANNING AND LAND USE MANAGEMENT COMMITTEE REPORT relative to an appeal filed for property located at 11965 - 11979 West Montana Avenue.

Recommendations for Council action:

1. FIND that this project will not have a significant effect on the environment, pursuant to the City's Environmental Guidelines and is in compliance with the California Environmental Quality Act; that the Mitigated Negative Declaration reflects the independent judgment of the City of Los Angeles; that the documents constituting the record of proceedings in this matter are located in Council File No. 14-0617 in the custody of the City Clerk and in the files of the Department of City Planning in the custody of the Environmental Review Section; and ADOPT the Mitigated Negative Declaration [ENV-2012-1111-MND-REC1] filed on April 12, 2013.
2. ADOPT the FINDINGS of the Los Angeles City Planning Commission (LACPC), including the Environmental Findings, as the Findings of the Council.
3. RESOLVE TO DENY THE APPEAL filed by Daniel Gryczman, on behalf of himself, Regent Properties and its principals and employees, from the entire determination of the LACPC in sustaining the decision of the Advisory Agency, and THEREBY APPROVE Vesting Tentative Tract No. 71898-CN, subject to Conditions of Approval, for a maximum 49 unit new condominium development in the Brentwood - Pacific Palisades Plan Area, for property located at 11965 - 11979 West Montana Avenue.


