SUMMARY

On November 13, 2019, the Public Safety Committee considered a November 8, 2019 Department of Animal Services (DAS) report relative to emergency evacuation planning for equine and large animals. After consideration, the Committee moved to recommend and request that the DAS, the Department of Planning, Bureau of Sanitation, and Bureau of Engineering create a heat map that reflects a high concentration of equine properties, utilizing data from, but not limited to, horse licenses, all equine keeping zones, and brown bins.



The attached heat map is a static version and the Bureau of Engineering will produce an interactive map for internal use by the Fire and Police Department.

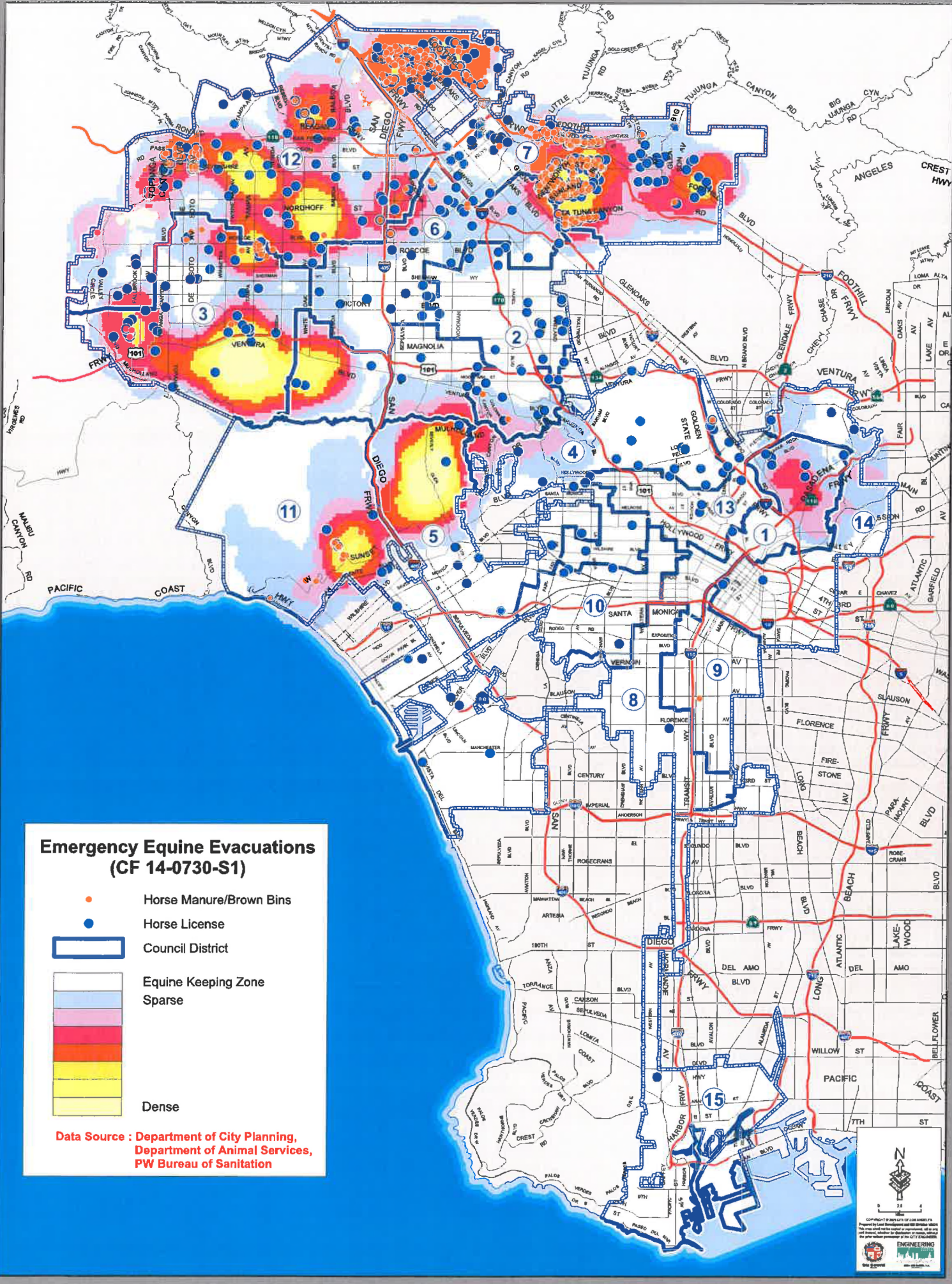
