Dear Honorable Members:

Transmitted herewith for City Council consideration are proposed contracting authorities related to the United States Department of Homeland Security Fiscal Year 2014 Urban Areas Security Initiative (FY14 UASI) grant award. On November 25, 2014, the City Council accepted the FY14 UASI grant in the amount of \$56,025,000 with a grant performance period from September 1, 2014 to May 31, 2016 (Council File No. 14-0820). On May 23, 2016, the California Governor's Office of Emergency Services (CalOES) approved a performance period extension through July 31, 2016. On October 31, 2016, CalOES approved a performance period extension through May 31, 2017, and on May 16, 2017, CalOES approved a performance period extension for the below projects through July 31, 2017.

Interoperable Communication Systems

LA-RICS

The Los Angeles Regional Interoperable Communications System (LA-RICS) is a collaborative effort of law enforcement, fire service and health service professionals with elected and appointed officials to implement a regional interoperable radio communications system. In UASI 14, LA-RICS has been allocated grant funding in the amount of \$4,997,544 for the purchase, installation and construction of communication towers and shelters.

Authority is being requested to negotiate and execute a contract amendment with the LA-RICS Joint Powers Authority to extend the contract through the new grant performance period to allow for final project payment.

ICI System

The Interagency Communications Interoperability System (ICI System) is a shared system with components purchased and constructed by individual cities and linked together through a microwave network in order to provide regional coverage. In UASI 14, ICI Systems has been allocated grant funding in the amount of \$4,997,543 for the following three ICI System partner jurisdictions: City of Santa Monica (\$2,997,543), City of Glendale (\$1,000,000), and City of Vernon (\$1,000,000). These allocations will be used to replace non-conforming non-interoperable conventional analog radio technologies with P-25 digital trunked radio technologies that will be interoperable within the ICIS regional radio system and the future LA-RICS platform.

Authority is being requested to negotiate and execute contract amendments with the City of Santa Monica and the City of Glendale to extend the contracts through the new grant performance period to allow for final project implementation and payment.

Recommendations

It is therefore requested that the City Council:

- 1. **Authorize** the Mayor, or designee, to:
 - a. Approve the time extension of the Fiscal Year 2014 Urban Areas Security Initiative (FY14 UASI) grant award, extending the grant performance period to July 31, 2017 (Attachment 1);
 - b. Negotiate and execute a UASI 14 amendment to the Subrecipient agreement with the Los Angeles Regional Interoperable Communications System Joint Powers of Authority for a total contract amount of \$4,997,554, and for a term not to exceed the end of the grant performance period, subject to the approval of the City Attorney as to form;
 - c. Negotiate and execute a UASI 14 amendment to the Subrecipient agreement with the City of Santa Monica for a total contract amount of \$3,537,044, and for a term not to exceed the end of the grant performance period, subject to the approval of the City Attorney as to form; and

- d. Negotiate and execute a UASI 14 amendment to the Subrecipient agreement with the City of Glendale for a total contract amount of \$1,498,677, and for a term not to exceed the end of the grant performance period, subject to the approval of the City Attorney as to form.
- 2. **Authorize** the Mayor, or designee, to prepare Controller instructions for any technical adjustments, subject to approval of the CAO, and authorize the Controller to implement the instructions.
