Richard Leyner

An established force in the San Fernando Valley's Commercial Real Estate market and a major force in the Valley's thriving mainstream business environment for many years, J. Richard Leyner is Senior Vice President of illi Commercial Real Estate, one of the foremost commercial real estate brokerage firms in Southern California, specializing in the leasing, sale & management of retail properties.

Mr. Leyner's success in the commercial real estate market derives from both his expertise in business and his personal involvement in the business community. Over the years, he has held many high-profile leadership positions including Chairman of the United Chambers of Commerce of the San Fernando Valley, President of the Encino Chamber of Commerce, President of the Neighborhood Council, and President of the Executive Committee of the Economic Alliance. He was a member of the Business Advisory Committee to Speaker of the House Robert Hertzberg and served on Assembly member Lloyd Levine's Advisory Commission. He also served as a member of the San Fernando Valley Transportation Strike Force.

Currently Mr. Leyner also serves the United Chambers of Commerce as Director of Finance and Marketing, is President of the Encino Business Improvement District, is Chairman of the Board of Valley Vote, and is Executive committee member to the Encino Chamber of Commerce and member of the Executive Committee of Economic Alliance. In 2006 Mr. Leyner was appointed Commissioner of the North Valley Planning Committee and today serves the committee as its President.

While his business involvement dwarfs the efforts of most, Mr. Leyner has always been a high achiever. Armed with a Bachelor's Degree in Marketing from New York University, he made his mark in the world of finance early in his career, when he became the youngest managing partner in Wall Street history, as managing partner of Leyner Dreskin and Company, member of the New York Stock Exchange. During his years on Wall Street Mr. Leyner was a member of the Appeals Committee of the New York Stock Exchange. He challenged the rule pertaining to capital requirements for participation in new issues and secondary offerings. As a result he was requested to rewrite the rule which was later adopted, therefore allowing all firms, both large and small, to participate in underwritings. In 1975, Mr. Leyner founded Leyner Enterprises, a New Jersey based business management consulting firm. After relocating to the West Coast in 1978 he obtained his California Real Estate license. From 1981-1987 he owned and operated two Red Carpet real estate franchises, dealing in both residential and commercial properties.

In 1987 Mr. Leyner joined Merrill Lynch Real Estate (now Prudential California Realty, Inc.) as Vice President-Branch Manager of the Encino office and Commercial Division, where he was responsible for overseeing twelve division offices. Prior to joining NAI Capital Commercial's Encino office, Mr. Leyner served as President of the Commercial Division of Bradbury and Company. In addition to managing two offices in the San Fernando Valley, he was one of the company's top producers. With his expertise and wealth of background in finance and real estate, Mr. Leyner served as Adjunct Professor of finance, marketing and management at Northrop University in Inglewood, California. He currently serves on the loan committee of VEDC (Valley Economic Development Center) a business non profit catering to the needs both financial and practical.

Mr. Leyner is the 2005 winner of the Fernando Award, the highest honor given in the San Fernando Valley for a lifetime of volunteerism. He is a past board member and President of the Commercial Division of the Southland Regional Association of Realtors, a member of International Conference of Shopping Centers, the National Association of Realtors and the California Association of Realtors. He is Chairman of the Board of the Child Development Institute, Executive Vice Chairman of the Board of New Directions for Youth, Interim Chairman of the Mid Valley YMCA, serving 2000 inner city members, Past President of B'nai Brith, Former Board Member of the Encino Tarzana Medical Center Foundation and is former fund-raiser for both Juvenile Diabetes Foundation and AIDS Project LA.

The division phone number is (213) 473-9343. Fingerprints must be taken **within three working days** from the **receipt** of this letter.

As part of the City Council confirmation process, you will need to meet with Mitch Englander, your Councilmember, and Councilmember Curren Price, the Chair of the Economic Development Committee, to answer any questions they may have. You will be hearing from a City Council committee clerk who will let you know when your appointment will be considered by the Economic Development Committee.
