Honorable Mayor, Members of the Los Angeles City Council, and Los Angeles Department of Water and Power, the Sierra Club Beyond Coal Campaign ("Campaign") is an all-volunteer, grassroots organization dedicated to advocacy for clean renewable energy alternatives that wean us off dangerous extreme fossil fuel extraction, transportation, storage, and refining projects in the City of Los Angeles and the region, state and nation. These moves put at risk the health and safety of our California neighborhoods, the sustainability of our ecosystems, and the stability of our global climate.

The Campaign helped organize an event last March 1st where over 100 organizations and almost a thousand activists came out in the streets of the Port of Los Angeles calling for clean energy solutions.
