When ordinance 85.02 went into effect, I was both an employee of Carlson Industries (the management company for the Brewery Artist Lofts in Lincoln Heights) as well as a resident of the Brewery. It quickly became clear that overnight vehicle dwelling could become a safety and health issue for the almost 800 residents of the Brewery. I took it upon myself to gather information and advocate for the community. I would like to thank Councilman Mike Bonin, who was a role model in handling the results of the same ordinance for his district. I contacted his office for advice on how to proceed and everyone I spoke to was understanding and helpful. Councilman Bonin's office has been proactive in trying to find solutions for everyone affected by ordinance 85.02. Your district is lucky to have you. At that time, I also reached out to Christina Miller, Deputy Mayor for City Homelessness Initiatives. She personally returned my call and we had a long discussion in which she was very supportive. She believed not only was it important that ordinance 85.02 not be applied to the streets surrounding the Brewery, but also that the unusual nature of the Brewery's residential use simply created an oversight. I agree with Christina. I believe this scenario is unintentional. But it is time to rectify it. Unfortunately, while I had great communication with many people regarding ordinance 85.02, I was never able to obtain support from Councilman's Gil Cedillo's office. They refused to reply to my many phone calls and emails, submitted regularly, over months. I also reached out directly to Cedillo's Deputy District Director, Jose Rodriguez, who, after my numerous attempts to communicate, finally replied with simply: there's nothing I can do. Without the buy-in of our District, I was unable to get any traction towards resolution. I have since moved onto other employment, but the lessons remain. I believe the administrators of District 1 would prefer that we work directly with you, the Homelessness and Poverty Committee, in order to rectify this unintentional consequence of 85.02 and its effect on the residents of the Brewery Artist Lofts in Lincoln Heights. Please help us. Thank you.
