Dear LA City Council Members:

I am opposed to the proposed ordinance to criminalize the act of lodging in a vehicle. I grew up in Los Angeles County and am currently a law student at UCLA and a resident of Los Angeles City.

As homelessness in LA increases, this ordinance creates more problems for our city, rather than solutions. In the absence of more affordable low-income housing, these individuals and families are left with no other option than to live in their vehicles. This ordinance would push individuals out of their vehicles, onto the streets, and into a more vulnerable position.

As City Council Members, you are tasked with representing and ensuring the safety of all residents, not just wealthy residents who don't want to be bothered by the sight of homelessness in the streets. I am not homeless, but it does not take much effort for me to imagine the severe impact that this ordinance will have on people who are out of other options and living in their cars. They will lose any measure of security and comfort that their car provides.

I support solutions for our housing crisis, but this ordinance is clearly not a solution. Instead, it calls into question Los Angeles City's actual commitment to supporting the safety and well-being of homeless individuals and families. I urge you to seek actual solutions and to not approve the proposed ordinance in Agenda Item 4, Council File 14-1057 Amending LAMC 85.02.
