MOTION

The City of Los Angeles has long recognized the value that employment opportunities provide to the City's youth for teaching responsibility, accountability, the importance of work, and other foundational workplace and life skills. Through the Youth Workforce Development System and the Summer Youth Employment Program (SYEP), the City has provided subsidized summer youth employment opportunities over the past decade, using a combination of federal and local public funds, private donations, private sector hiring, and community-based efforts.

In August 2014, the Los Angeles County (County) Department of Community and Senior Services (DCSS) advised the Economic and Workforce Development Department (EWDD) of its award of \$711,463 to provide 370 participants with job training and paid work experience to low and moderate income youth ages 14-21 in areas specified by DCSS.

Goldman Sachs, recognizing the importance of the SYEP and the need to support the City's efforts to provide employment opportunities for the youth of Los Angeles, has generously donated an additional \$250,000 in support of the SYEP which was deposited into Mayor's Fund for Los Angeles (Mayor's Fund). The Mayor's Fund is a private non-profit organization supported by private donations and is overseen by an independent Board of Directors.

This funding will enable the City to provide subsidized work experience to an additional 125 youth in the South and East areas of the City. With the recent approval of the 2014-15 Workforce Investment Board (WIB) Year Fifteen Annual Plan (Annual Plan), the Council granted EWDD the authority to accept funds and execute agreements with service providers for SYEP.

I THEREFORE MOVE that the City Council, with the concurrence of the Mayor:

1. AUTHORIZE the General Manager, Economic and Workforce Development Department (EWDD), or designee, to accept on behalf of the City \$711,463 from the Los Angeles County DCSS and \$250,000 from Mayor's Fund (Goldman Sachs) to provide job training and paid work experience to qualifying youth in areas specified by DCSS (Attachment A).
2. AUTHORIZE the General Manager, EWDD, or designee, to negotiate and execute new contracts and/or contract amendments for the County youth jobs program (Attachment A).
3. AUTHORIZE the Controller to:
  - a. Establish a receivable within the TANF Fund No. 56E from the LA County for \$711,463.
  - b. Establish a new account and appropriate within the TANF Fund No. 56E as follows:
