PUBLIC SAFETY COMMITTEE REPORT relative to the 2018-19 Off-Highway Motor Vehicle Recreation (OHMVR) Grant - Education and Safety Program.

Recommendations for Council action, SUBJECT TO THE APPROVAL OF THE MAYOR:

- 1. AUTHORIZE the Chief, Los Angeles Police Department (LAPD), or designee to:
 - a. Retroactively apply for and accept the grant award in the amount of \$76,052 from the State of California, Department of Parks and Recreation (Grantor) for the 2018 OHMVR Grant - Education and Safety Program for the period of January 1, 2019 through December 31, 2019.
 - Negotiate and execute the Cooperative Agreement, subject to the review and approval of the City Attorney as to form.
 - c. Negotiate and execute an Agreement with the National Youth Project Using Minibikes (NYPUM) for the LAPD to operate a local NYPUM youth program, subject to the review and approval of the City Attorney as to form.
- 2. AUTHORIZE, the LAPD to:
 - Submit grant reimbursement requests to the Grantor and deposit grant receipts in Fund No. 339/70.
 - b. Spend up to the total grant amount of \$76,052 in accordance with the grant award agreement.
 - c. Prepare Controller instructions for any technical adjustments, subject to the approval of the City Administrative Officer (CAO); and, authorize the Controller to implement the instructions.
- 3. AUTHORIZE the Controller to:
 - a. Establish a grant receivable and appropriate \$76,052 to an appropriation account to be determined, in Fund No. 339/70, for the receipt and disbursement of the 2018-19 OHMVR Grant - Education and Safety Program funds.
 - b. Increase appropriations as needed from Fund No. 339/70, appropriation account number to be determined, to Fund No. 100/70, account number and amount as follows:

Account <u>Title</u> <u>Amount</u> 001092 Overtime Sworn \$30,900

- 4. AUTHORIZE the City clerk to:
 - a. Place the following action relative to the 2018 OHMVR Grant Education and Safety

Program on the City Council agenda on July 1, 2019 or the first meeting day thereafter:

Authorize the Controller to transfer from Fund No. 339/70, account number to be determined, to Fund No. 100/70, account number and amount as follows:

<u>Fiscal Impact Statement</u>: The CAO reports that approval of the recommendations within this report will provide \$76,052 in funding to the LAPD for the 2018 OHMVR Grant - Education and Safety Program. The grant requires a 25 percent match that will be fulfilled through the equivalent salary expenditures of the Police Reserve Officers. Funding for the one Police Sergeant and four Police Officers is already provided as a part of the LAPD's 2018-19 Adopted Budget and there is no additional impact to the General Fund. The recommendations in this report comply with the City's Financial Policies in that one-time revenue is used for one-time expenses.

Community Impact Statement: None submitted.

SUMMARY

At its regular meeting held on February 13, 2019, the Public Safety Committee considered reports from the CAO and Board of Police Commissioners relative to the 2018-19 OHMVR Grant - Education and Safety Program.

The CAO reports that the LAPD is seeking approval to retroactively apply for and accept an award of \$76,052 for the 2018 OHMVR Grant - Education and Safety Program from the State of California for the grant term of January 1, 2019 through December 31, 2019. The grant requires a 25 percent match that will be fulfilled through the equivalent salary expenditures of five Police Reserve Officers.

The CAO further reports that the purpose of the OHMVR Grant - Education and Safety Program is provide financial assistance to local and federal agencies that deliver safety programs and education to the public regarding responsible off-highway safety. The LAPD will be partnering with the NYPUM to introduce off-highway vehicle recreation and education to LAPD youth program participants. Acceptance of this grant will allow the LAPD to incorporate the NYPUM Program into LAPD's existing youth programs, providing at-risk and disadvantaged youth with awareness of off-highway vehicle activities and areas, as well as hands-on and classroom safety training.

After consideration, and after providing an opportunity for public comment, the Committee approved the recommendations in the CAO report. This matter is now forwarded to the Council for its consideration.
