Dear Los Angeles Mayor Garcetti and Councilmembers,

The Historic Highland Park Neighborhood Council (HHPNC) represents over 60,000 Los Angeles Stakeholders who reside, own property, or conduct business in the neighborhood of Highland Park. HHPNC opposes Council File #14-1349-S1, #14-1349-S2, #14-1349-S4 and all related council files, which calls for the formation of a LA River Enhanced Infrastructure Financing District (EIFD) due to a lack of a concrete and detailed EIFD policy, a boundary map, a list of proposed projects, a preliminary fiscal and social impact analysis, a public hearing in the river impacted communities, or a financial analysis as required by the County of Los Angeles. The proposal for a City of LA EIFD is not fully developed or analyzed and should not be approved.

A 32-mile district, extending one mile on either side based on tax increment will have a negative effect on our neighborhoods. Tax increment financing districts rely on growth, and increasing the property value of the lots, through new, high-density development does not seem viable. Councilman O'Farrell mentioned the new EIFD would run, the 32mile length of the river, and incorporate residences and businesses within one mile on either side of the Los Angeles River with no increased taxes. However, there is no financial feasibility study of the proposed project area, nor has a map or specific project descriptions been prepared.

The Los Angeles City Council should focus to adopt community plan updates for the communities along the Los Angeles River, before an Enhanced Infrastructure Financing District is approved. There are several elements that need to be provided before such a plan is implemented, such as a social impact analysis per LA County EIFD Policy, a specific project map, a specific list of projects, and a financial analysis of the cost and benefit, versus the loss of affordable housing and social displacement of hundreds of thousands of Angelenos.
