An ordinance adding Section 186.14 to Article 6 of Chapter XVIII of the Los Angeles Municipal Code clarifying that other provisions do not supersede the Citywide Hotel Minimum Wage Ordinance.

**THE PEOPLE OF THE CITY OF LOS ANGELES  
DO ORDAIN AS FOLLOWS:**

Section 1. A new Section 186.14 is added to Article 6 of Chapter XVIII of the Los Angeles Municipal Code to read as follows:

**SEC. 186.14. COEXISTENCE WITH OTHER ORDINANCES.**

This article is not superseded by any requirement in Article 7 of Chapter XVIII of the Los Angeles Municipal Code.

Sec. 2. The City Clerk shall certify to the passage of this ordinance and have it published in accordance with Council policy, either in a daily newspaper circulated in the City of Los Angeles or by posting for ten days in three public places in the City of Los Angeles: one copy on the bulletin board located at the Main Street entrance to the Los Angeles City Hall; one copy on the bulletin board located at the Main Street entrance to the Los Angeles City Hall East; and one copy on the bulletin board located at the Temple Street entrance to the Los Angeles County Hall of Records.

Section 1. A new Section 10.37.15 is added to Article 11 of Chapter 1 of Division 10 of the Los Angeles Administrative Code to read as follows:

**Sec. 10.37.15. Coexistence with Other Ordinances.**

This article is not superseded by any requirement in Article 7 of Chapter XVIII of the Los Angeles Municipal Code.
