RECOMMENDED ACTIONS

- 3. That the Board REQUEST the Mayor and City Council to AUTHORIZE the Los Angeles Police Department (LAPD) to reprogram funds totaling \$60,077 within the 2012 Solving Cold Cases with DNA Program from the United States Department of Justice, Office of Justice Programs, National Institute of Justice, as follows:

That the Board REQUEST the Mayor and City Council to AUTHORIZE the Chief of Police or designee to ACCEPT the no-cost extension for the 2012 Solving Cold Cases with DNA Program from the United States Department of Justice, Office of Justice Programs, National Institute of Justice, extending the award period to March 31, 2015;

- 5. That the Board REQUEST the Mayor and City Council to:
 - A. AUTHORIZE the Chief of Police, or designee, to execute the First Amendment to Contract No. C-121595, between the City of Los Angeles and The Bode Technology Group, Inc., extending the term of the agreement from September 30, 2014 to March 31, 2015, subject to City Attorney approval as to form and legality;
 - B AUTHORIZE the Chief of Police, or designee, to execute the First Amendment to Contract No. C-122276, between the City of Los Angeles and Cellmark Forensics, Inc., extending the term of the agreement from September 30, 2014 to March 31, 2015, subject to City Attorney approval as to form and legality.
- 6. AUTHORIZE the LAPD to prepare Controller Instructions for any technical adjustments, subject to the approval of the CAO, and AUTHORIZE and INSTRUCT the Controller to implement the instructions.

DISCUSSION

The Los Angeles Police Department (LAPD) requests approval to reprogram funds totaling \$60,077. Funds would be transferred from Personnel, Equipment, and Contractual to Travel and Other.

Investigators are working fewer overtime hours than originally planned. The Personnel category will be decreased by \$22,586. Fewer cases are being sent to the contract laboratories, resulting in a \$20,410 decrease in the Contractual category, and \$17,081 in the Equipment category will be moved to the Other category. The reprogramming of funds will allow the Department to fund conferences and training for detectives from the Cold Case Homicide Unit.

The LAPD is also seeking approval to accept a six-month no-cost extension. The extension will allow the LAPD to fully utilize grant funds and implement the revised budget. Moreover, the LAPD also requests approval to amend contracts with The Bode Technology Group and Cellmark Forensics to accommodate the no-cost extension.

LOS ANGELES POLICE DEPARTMENT 2012 Solving Cold Cases with DNA 2012-DN-BX-K010 Justification

LAPD requests permission to decrease the budget for Personnel by 22,586. Personnel have been working less overtime than originally anticipated.

LAPD requests permission to increase the Travel budget by \$27,447. The additional funding will be used to allow five or six detectives to attend the International Homicide Investigators 21st Annual Symposium, Cold Case Homicide Conference, and California Homicide Investigators Association Conference.

LAPD requests permission to decrease the Equipment budget by \$17,081. All items previously listed in the Equipment category cost less than \$5000 each. The items do not meet the LAPD's capitalization policy for the classification of equipment. LAPD requests permission to move the items to the Other category.

LAPD requests permission to decrease the Contracts/Consultants budget by \$20,410.00. As contract laboratories become more efficient, costs to analyze samples have decreased.

LAPD requests permission to increase the budget in the Other category by \$32,630. Items that were in the Equipment category have been moved to the Other category.

In the Other category, LAPD requests permission to purchase rolling file cases. The cases will be used solely by Cold Case detectives. The cases have internal frames that can hold hanging file folders. This will allow detectives to transport DNA reports, case files, and other documentation.

The LAPD respectfully requests approval of this GAN. The GAN will assist the LAPD in providing the Cold Case Unit with urgently needed equipment and making maximum usage of the award amount.

Budget Narrative for Personnel:

Detective Overtime

Twelve detectives, who receive an average of \$81 an hour in overtime pay, will work 1,361.5 hours of overtime to review and investigate 350 cases for a total of \$110,283. The 1,361.5 hours is derived by multiplying 3.89 hours, the average time to review a case, by 350 cases. Each week, a team of detectives will review multiple cases. Detectives working on the program will be rotated to ensure that every one is provided an opportunity to learn and participate, and that no one burns out, since they may need to work overtime for other reasons like court appearances.

Calculations

350 Cases x 3.89 hours per case = 1,361.5 overtime hours

\$81 per hour x 1.361.5 hours = \$110.281.50

1,361.5 hours / 12 Detectives = 113.45833 average hours (or units) per Detective

Criminalist Overtime

The LAPD has allocated a total of \$31,995.00 in overtime pay for Criminalists. The LAPD expects that 40% of the 350 cases reviewed (approximately 140 cases) will have biological evidence. Criminalists, who earn an average of \$79 in overtime pay, will require 0.90 hours per case to review 140 case packets for a total of \$9,954.00 in overtime. Criminalists will also require 2.75 hours per case to perform data review for approximately 84 cases (60% of the 140 cases typed) prior to uploading developed profiles into CODIS. This equates to an additional \$18,249.00 in overtime. Criminalists will require 0.80 hours to review, log the findings and generate reports for approximately 56 cases (40% of the 140 cases typed) that were not CODIS suitable at a cost of \$3,539.20 in overtime.

Calculations

140 case packets x 0.88 hours per case = 123.20 hours 123.2 hours x \$79 per hour = \$9,732.80

84 cases x 2.75 hours per case = 231.00 hours 231.0 hours x \$79 per hour = \$18,249.00

56 cases x 0.91 hours per case = 50.96 hours

50.96 hours x \$79 per hour = \$4,025,86

Total Criminalist Overtime Hours = 405.16 hours (123.20 + 231.00 + 50.96 = 405.16 hours)
Total Criminalist Overtime Cost = \$32,007.66 (\$9,732.80 + \$18,249.00 +\$4025.86 = \$32,007.66)

405.16 hours / 90 Criminalists = 4.50178 average hours (or units) per Criminalist

Laboratory Technician Overtime

The LAPD has allocated a total of \$31,2560.40 in overtime pay to Laboratory Technicians. The LAPD expects that 40% of the 350 cases reviewed (approximately 140 cases) will have biological evidence. At an average overtime pay of \$61 an hour, the Laboratory Technicians will review, package, and return to evidence 140 cases, taking 3.5 hours for each case at a total cost of \$28,890. Also, \$1,708.00 in overtime will be needed to package the anticipated 28 CODIS "hits" and ship the reference samples for confirmation. Laboratory Technicians require 0.80 hours per sample for packaging (28 samples x \$61 x 0.80 hours per sample = \$1,366.40).

140 case packets x 3.5 hours per case = 490.0 hours 490.0 hours x \$61 per hour = \$28.890.00

28 cases x 0.8 hours per case = 22.4 hours 22.4 horus x \$61 per hour = \$1,366.40

Total Laboratory Technician Overtime Cost = \$31,256.40 (\$28,890.00 + \$1,366.40 = \$31,256.40)

Senior Property Officer Overtime

The LAPD expects that 40% of the 350 cases reviewed (approximately 140 cases) will have biological evidence. Evidence items for the 140 cases will need to be retrieved from the property rooms. \$714.00 in overtime will be needed for 2 Senior Property Officers to review and approve documentation and evidence transfers for 140 cases. Senior Property Officers require 0.10 hours per case at a rate of \$51 per hour (140 samples x \$51 x 0.10 hours per case = \$714.00).

Calculations

140 cases x 0.10 hours per case = 14.0 Senior Property Officer overtime hours

14.0 hours x \$51 per hour = \$714.00 Senior Property Officer overtime cost

14.0 hours / 2 Senior Property Officers = 7.0 average hours (or units) per Senior Property Officer

Property Officer Overtime

The LAPD expects that 40% of the 350 cases reviewed (approximately 140 cases) will have biological evidence. Evidence items for the 140 cases will need to be retrieved from the property rooms. The LAPD has allocated a total of \$3,778.26 in overtime pay to Property Officers. At an average overtime pay of \$41 per hour, the 10 Property Officers will document and retrieve Cold Case evidence items from storage for 140 cases, taking 0.3 hours for each at a total cost of \$1,722.00.

Calculations

140 case packets x 0.3 hours per case = 42.0 Property Officer overtime hours

42.0 hours x \$41 per hour = \$1,722.00 Property Officer overtime cost

42.0 hours / 10 Property Officers = 4.2 average hours (or units) per Property Officer

Budget Narrative for Travel:

The LAPD allocated \$32,483 in travel costs for LAPD detectives to attend conferences and training. Expenses for five detectives to attend the International Homicide Investigators Association (IHIA) 21st Annual Symposium were \$10,955. Six detectives plan to attend the Cold Case Homicide Conference at an estimated cost of \$10,764. Six detectives plan to attend the California Homicide Investigators Association Conference at an estimated cost of \$10,764.

The conferences will allow the detectives to interact with other law enforcement investigators from throughout the United States as well as members of prosecuting agencies, federal law enforcement officers, and subject matter experts. The conferences will include presentations on subjects such as prosecuting cold case homicides, blood pattern analysis, crime scene reconstruction, victimology, behavioral analysis of violent crime, and media relations. The conferences will enhance the detectives' investigation skill and promote the interaction between different agencies.

The LAPD will utilize a total of \$257,425 for contract laboratory services. Due to an increasing demand on its services, the LAPD Laboratory cannot perform the screening and/or testing of the biological evidence that is retrieved. The LAPD anticipates that 40% or 140 of the 350 cases will have biological evidence that can be tested. Any biological evidence from the 140 cases will be shipped to a contract laboratory for screening. Three samples from each of the 140 cases (a total of 420 samples) will be screened at a cost of \$325 per item for a total cost of \$136,500. The LAPD further anticipates that 84 cases (60% of the 140 cases) will require DNA typing. Each of the 84 cases will require testing of 3 samples per case for a total of 252 samples. At a cost of \$425 per sample, typing will cost of \$107,100. It is anticipated that multiple samples from the same case will usually yield only one DNA profile foreign to the victim. In those instances, only one sample will be uploaded into CODIS, resulting in approximately 144 unique DNA profiles added to the DNA database. Based on current rates, 25 profiles will require confirmatory typing (30% of the 84 cases). These 25 profiles will require typing with one sample per case at a cost of \$553 per typing. This results in a cost of \$13,825 (25 profiles x 1 sample per case x \$553 per typing = \$13,825).

The Los Angeles Police Department (LAPD) budget for the 2012 Solving Cold Cases with DNA Program (Program) promotes the apprehension of individuals, who have committed homicides and UCR Part I violent crimes, through the review of casebooks/files to determine the solvability by the retrieval and analysis of DNA evidence. In addition, the budget facilitates the investigation of "cold" homicides and other Part I violent crime cases prior to and after initial DNA testing, re-testing, or the receipt of a direct "hit" on a specific case, ensuring successful prosecution of these crimes. No other law enforcement agency has as great or similar need to review the volume (over 6,000) of unsolved cold case homicides. The goal of these cold case reviews is to bring the suspects to justice, no matter how much time has passed, and provide closure for the victims' families.

Personnel Services

The LAPD will provide overtime to Detectives, Laboratory Technicians, Criminalists, Senior Property Officers, and Property Officers. The overtime will provide the LAPD with the ability to allow these employees to perform their primary duty assignments and assist with the successful implementation of this program.

Detectives will work overtime to review and investigate 350 cases. Through analysis of prior overtime records, the average time for a detective to review each case is 3.89 hours. Each week, a team of detectives will review multiple cases. Detectives working on the program will be rotated to ensure that every one is provided an opportunity to learn and participate, and that no one burns out, since they may need to work overtime for other reasons like court appearances.

The LAPD has allocated overtime funds for Laboratory Technicians and Criminalists.

Based on results from prior cases, the LAPD expects that 40 percent of the 350 cases reviewed will have biological evidence. This equates to 140 cases.

Criminalists require 0.90 hours to review case packets that contain biological evidence. The average time for Criminalists to perform data review prior to uploading developed profiles into CODIS is 2.75 hours per case. Criminalists require 0.91 hours to review, log the findings and generate reports. The times required for Criminalists to perform these tasks were obtained through analysis of prior overtime records. The average times necessary to complete the tasks listed above were calculated.

Laboratory Technicians require 3.5 hours per case to document and package cases with biological evidence that will be sent to the contract laboratories. Laboratory Technicians require 0.8 hours per sample for packaging CODIS "hits" and their associated reference samples. The times required for Laboratory Technicians to perform these tasks were obtained through analysis of prior overtime records. The LAPD examined the overtime records for Laboratory Technicians and calculated the average times necessary to complete the tasks listed above.

The LAPD has allocated overtime pay to Property Officers and Senior Property Officers.

Cases with biological evidence will need to be retrieved from the property rooms. After analysis, evidence items will need to be returned to the property rooms. These tasks will be the responsibility of Property Officers and Senior Property Officers.

Property Officers will require 0.3 hours per case to document and retrieve Cold Case evidence items from storage. Senior Property Officers will require 0.10 hours per case to review and approve documentation and evidence transfers.
