

MOTION

I MOVE that the Council Action of 11/7/14 relative to the use of outside counsel in the case of *City of Los Angeles v. Patel* (CF 14-1509) BE AMENDED to authorize the City Attorney to retain the services of Orin S. Kerr to assist in this matter and to process and execute any documentation as may be needed for this purpose; to FIND that the work to be performed by Orin S. Kerr are for professional, scientific, expert, technical, or other services of a temporary and occasional character for which competitive bidding is not practicable or advantageous and that the work can be performed more economically or feasibly by independent contractors than by City employees; and to APPROPRIATE, subject to the approval of the Mayor, \$10,000 from the "Outside Counsel Including Workers Compensation" line item in the Unappropriated Balance Fund No. 100-58 to the City Attorney Fund No. 100-12, Account No. 009301 (Outside Counsel), to pay for these services.


