- 3. AUTHORIZE the City Attorney to pay unpaid overtime in the amount of \$125,502.33 plus accrued interest to be paid to plaintiffs as wages as set forth in Exhibit A, attached to Motion, to be paid from Fund No. 100, Department 38, Account 001093.
- 4. AUTHORIZE the City Attorney, or designee, to prepare Controller instructions for any necessary technical adjustments, subject to the approval of the City Administrative Officer, and AUTHORIZE the Controller to implement the instructions.
