Subject: LOS ANGELES STREET CIVIC CENTER BUILDING (PARKER CENTER SITE) AND CERTIFICATION OF THE FINAL ENVIRONMENTAL IMPACT

REPORT - CF 14-1604

At its meeting of August 25, 2016, the Municipal Facilities Committee (MFC) reconfirmed its designation of Alternative B3 as the City's preferred alternative and approved the revised schedule from the Bureau of Engineering to finalize the Environmental Impact Report process by the end of February 2017. Below are the recommendations necessary to effectuate the finalization of the Parker Center Site EIR Project.

RECOMMENDATIONS

That the actions for Committee and the City Council subject to approval by the Mayor as follows:

- 1. Review and consider the attached (2016) EIR, which finds that the project will have significant environmental impacts.
- 2. Certify that:
 - a. The EIR was completed in compliance with the California Environmental Quality Act (CEQA):
 - b. The City Council reviewed and considered the information contained in the Final EIR dated November 2016 prior to approving the project (Transmittal 2);
 - c. The Final EIR reflects and expresses the City's independent judgment and analysis; and
 - d. The documents constituting the record of proceedings in this matter are in the custody of the City Clerk and in the files of the Department of Public Works, Bureau of Engineering (BOE).
- 3. Adopt the Findings of Fact and Statement of Overriding Considerations dated November 2016 (Transmittal 3).

- Approve Alternative B3 demolition of the existing facility with recordation, then replacement with a new 753,730 gross square feet building and 1,173 parking spaces as described in the EIR.
- 5. Adopt the mitigation monitoring plan contained in the Final EIR.
- Instruct City staff from CAO, BOE, and the CLA to report back on a financial analysis for the project to the Council.
- Instruct the Chief Legislative Analyst and City Administrative Officer to make technical corrections, as necessary, to those transactions included in this report to implement the Mayor and Council's intent.
- Re-approve the use of \$10,000,000 in Municipal Improvement Corporation of Los Angeles (MICLA) financing included in the Fiscal Year 2014-15 Adopted Budget for the New Civic Center Building included in the Capital Improvement Expenditure Program.
