Dear L.A. City Council;

My name is Hanna Collins, I am a middle income 33 year old freelance sound mixer, expecting mother, and a home owner in Los Angeles. I don't think you fully understand the gravity of what Airbnb is doing in our community.

Normally when you are about to have a child or already have a family in a city such as Los Angeles, New York or San Francisco and you are middle income you are forced to move away from your community in an effort to afford a life for your family. Thanks to the extra income we earn from Airbnb, we're able to afford to pay our mortgage without stress during slower times in the film industry. This ensures we stay in our community so that we can raise our child in our supportive network. Not only that but the extra income will also allow me to stay at home more with my child. Airbnb is doing for the middle class what I feel the government is not able to do the ability to afford to own a home in our community instead of resigning ourselves to renting or moving.

I also think there's a misconception of who is using Airbnb. We make sure to vet each and every guest that we host to make sure they are respectable people. The majority of people who stay at our home used to live in Venice or they come here frequently for business or to visit family. We've had photographers, composers, graphic designers, producers, and advertising executives just to name a few professions. These are people that specifically stay in our area because they are already connected to the people in it.

My day rate has not gone up since I started working in production sound in 2007 and I am not the only one who has not seen an increase in income despite a sharp increase in costs to live in this city. We all are aware that the longer they keep the interest rates this low the worse inflation is going to become. So what are my options? What can I do as an individual who has worked hard and lived fiscally responsible her entire life do to keep her middle income life and be a present parent? Airbnb has been my solution and I think it's been many others. We are not contributing to lack of affordable housing. If we decided to rent our home out in Venice it wouldn't even be considered "affordable" for the majority of the population.

Airbnb is only a part of this new share society and I believe it is coming from a place of people trying to find other ways to afford their lives and I don't see it stopping anytime soon. Bike share programs, Uber, Zipcar, Airbnb, ThredUp, and any other way people are sharing the cost of living is your citizens trying to make living in your city work for them. Maybe it's unconventional but I don't think conventional is working anymore for anyone other then the upper class. Please be aware that by targeting Airbnb you are also targeting your middle class who is trying to make their housing and their lives affordable without your assistance. This is what Airbnb is doing for your community.
