Dear Chair Cedillo and Members Krekorian and Harris-Dawson:

I am an attorney and Chair/President Emeritus of Pacific Palisades Community Council (PPCC). I write today in my individual capacity.

PPCC is a member of the Westside Regional Alliance of Councils (WRAC). WRAC submitted a position letter to this file dated Feb. 5, 2018 (http://clkrep.lacity.org/onlinedocs/2014/14-1635-S2_pc_02-05-2018.pdf) which states, among other things, the following

"The Westside Regional Alliance of Councils (WRAC) is a coalition of all 13 neighborhood and community councils in Council Districts 5 and 11. A supermajority of WRAC members (10 of 13) supports adoption of certain "essential provisions" in connection with any proposed City ordinance allowing short term rentals in presently prohibited zones, including:

1) Establishment of an annual cap on the number of nights per host for short term rentals; although WRAC members have taken varying positions on the actual number for the annual cap, we support the basic principle that such a cap should apply to all hosts; i.e., provision should not be made, via a CUP or other process, for individual hosts to receive permission to exceed the established annual cap." [highlighting added.]

The WRAC letter expresses the position of PPCC, as set forth in letters previously submitted to this Council File and posted on the PPCC website, www.pacpalicc.org (documents/motions & positions). PPCC additionally passed a resolution on Feb. 22, 2018, which opposes establishment of a CUP or other process for individual hosts to exceed the annual cap. I respectfully urge you to disapprove any provision for a process for individual hosts to receive permission to exceed the established annual cap.

I further urge you to consider the serious concerns expressed in prior public testimony to the PLUM Cmtee by PPCC, Bel-Air Beverly Crest Neighborhood Council and Councilmember Koretz, regarding the serious potential fire hazard, especially in hillside and bluffs areas, if hosts are allowed to rent out homes on a short-term basis for long periods of time throughout the year (which would be present with the proposed process to exceed the annual cap).
