#### Councilman Huizar,


I'm writing to you to let you know I'm opposed to the proposed 180 day cap for home sharing in the City of Los Angeles. I've owned my home in Hollywood for 16 years. In that time I have been a part of the huge regentrification of Hollywood. I've restored my 1916 Craftsman home, and have enjoyed living on the property until 1 1/2 years ago.

I am now renting my Hollywood home via airbnb and vrbo. I've had nothing but amazing experiences over the last year and a half. I pay my 14% tax to the city on every rental. I pay my housekeeper close to \$800/month... very different from when I lived there and paid her \$100/month. I have 5 star ratings on the websites. This is a very safe and quiet home for kids and families coming to the area. It gives them a more homey option than renting a few separate hotel rooms to stay as a family, and I work hard to create a beautiful safe setting for people who stay at my home. I travel for a living, being a musician, and its nice to be able to rent my home as I wish when I wish. I know I'm contributing to the economy of the city by doing this. I hope you'll consider my story when deciding on putting what I feel is an unnecessary cap on home sharing.
