The Information Technology Agency (ITA) is submitting the attached strategic plan for 2014-2017 for your consideration.

As the second largest City in the United States, Los Angeles is embracing technology at a rapid pace and innovation has become a top priority for the leadership of the City. The ITA is dedicated to serving City Departments, Elected Officials, and the Public with a wide variety of information technology (IT) services.

The ITA 2014-17 Strategic Plan focuses on goals of rebuilding our infrastructure and enhancing our abilities to innovate. Some of the exciting projects the ITA is pursuing in support of the Elected Offices, Council controlled departments and the community include:

- Enhancing reliability of the Data Network and replacing end of life RLAN network
- · Setting standards for 10 years for e-mail, office software and various other desktop and enterprise software solutions
- Fiber expansion to all City-owned facilities
- Phone system replacement with a new City standard Voice Over IP (VOIP) solution
- New 311 Customer Relationship Management (CRM) system
- Procurement reform including replacing legacy purchasing system
- Developing an RFP to re-host applications to the IBM Mainframe for a more costeffective platform
- Migrating remaining City departments to Active Directory and a new Identify Management system to simplify application integration
- Modernizing the ITA data center with new air conditioning, walls, tiles and racks

- Replacing the legacy Content Management System with Drupal and hosting LACity.org with Acquia
- LA Community Broadband Network (LACBN) for Broadband connectivity to every City of LA Household to ensure affordable access to all Angelinos
- Partnering with non-profits to build a Digital Inclusion program to provide low cost PCs to low income households
- Enhancing the Security Operation Center and collaborating with the Cyber Intrusion Command Center to design a comprehensive center with line of site to all City networks
- Implementing an out of state offsite Disaster Recovery solution with Switch and investigating a solution for replacing tape backup with an on-line solution
- Implementing an IT Classification Study to place new titles and specifications for IT Positions in an effort to attract and retain the talent and skill sets needed, develop an internship, and contract to hire a program to deal with succession planning
- Rolling out WiFi for all elected officials offices
- Implementing Performance Based Budgeting module in the City's ERP
