DRAFT ORDINANCE AMENDING SECTION 56.11 OF CHARTER V OF THE LOS ANGELES MUNICIPAL CODE TO ADDRESS THE STORAGE OF PERSONAL PROPERTY IN PUBLIC AREAS

Honorable Members:

On January 22, 2016, at the request of Council, the City Attorney prepared and transmitted two versions of an ordinance to amend Section 56.11 of the Los Angeles Municipal Code which addresses the storage of personal property in public areas. Those draft ordinances were considered first by the Public Works and Gang Reduction Committee on January 25, 2016 and, thereafter, by the Homelessness and Poverty Committee on March 17, 2016.

The Public Works and Gang Reduction Committee approved the draft ordinance which was identified as Ordinance B, with two recommended modifications. The Homelessness and Poverty Committee, thereafter, recommended to Council that the City Attorney prepare and present an ordinance, in substantial conformance with the Ordinance identified as Ordinance B, with several amendments, including the amendments recommended by the Public Works and Gang Activity Committee.

So as to provide a document which clearly presents for Council's consideration, the recommendations submitted by both Committees in the context of a draft Ordinance, the City Attorney has prepared and transmits the enclosed draft ordinance, approved as to form and legality, which includes all of the amendments recommended by the two Committees.
