As a resident of NELA and someone who commutes on Figueroa Street daily, I was shocked to hear about Councilman Cedillo's plan for diagonal parking along the Figueroa corridor. Not only do I believe traffic will be adversely affected by such a parking strategy, it also creates an unsafe environment for drivers, pedestrians, and bicyclists.

Diagonal Parking reduces the cone of vision for drivers and shortens the reaction time for bicyclists. Reversing from a diagonal spot, the drivers line of sight is restricted by surrounding vehicles. The use of car mirrors, designed to provide lines of sight for the driver, only really work to see directly behind the vehicle. A Diagonal parking strategy unnecessarily creates blind spots for the reversing car. Consequently, cyclists will have less time to react to drivers reversing from a parking spot. Drivers, of course, will also have less time to see the cyclists and other cars. This proposal will lead to more bike / car and car / car collisions while slowing the flow of traffic in a more dangerous way.

The North Figueroa corridor already has a steady stream of bike traffic and car traffic. Too often the roadway is deemed unsafe and bicyclists take to the sidewalk. This too is more dangerous for cars, pedestrians, and cyclists. Cars turning a corner are not used to seeing someone move as quickly as bicycles do on a sidewalk. I ride a bike, am very aware of bicyclists, and have come close to collisions because of bicyclists riding on the sidewalk and "shooting out" into the intersection while crossing the street. Bicycles on the sidewalk move too quickly and pose a danger to people walking on the sidewalk or exiting a business. Councilman Cedillo's plan will exasperate the problem of bicyclists riding on the sidewalk, creating an unsafe environment for Pedestrians, drivers, and cyclists.

Councilman Cedillo's proposal for diagonal parking is wrong for the North Figueroa Corridor. This is a diverse urban community that includes folks riding bikes, commuting in cars, and walking along the sidewalk. I urge the council to reject Councilman Cedillo's diagonal parking plan and continue to move the city forward with safety and equality for all residents in mind. Parallel parking with a bike lane on the North Figueroa corridor will provide a safer and more vibrant street life for all users of the North Figueroa Corridor.

I am writing to state my opposition to Councilmember Cedillo's "Great Streets" plan for North Figueroa Boulevard. Councilmember Cedillo's plan calls for diagonal parking at the expense of bike lanes on North Figueroa Boulevard. While this is partly disconcerting because Councilmember Cedillo claimed to support bike lanes during his campaign, this issue is bigger than one politician's broken promise. Councilmember Cedillo claims that diagonal parking is about safety, but this could not be further from the truth. Bike lanes make streets safer for cyclists and drivers, not diagonal parking.

Here are the facts about bike lanes:

- In 2012, the [American Journal for Public Health](#) published a study that demonstrated how the implementation of bike lanes can cut the injury risk by **50%**.
- A [University of Washington](#) study showed that major streets with bike lanes have a crash rate **38%** then streets without any bicycle facilities.
- A University of Texas - Austin study revealed that **bike lanes keep also keep motorists safer**, because drivers passing cyclists on roads without bike lanes veer farther left into the next lane of traffic.
- This [Department of Transportation](#) study suggests that cyclists will obey stop signs more often if a bike lane is present. The study also further backs the idea that **bike lanes also keep motorists safe**, by curtailing the number of motorists who inadvertently cross into an occupied line while passing a cyclist.
- Bike lanes also help to alleviate traffic, as cyclists will not have to slow down the flow of traffic by taking up a full automobile lane.

This is an exciting time for the City of Los Angeles. Once an all around transportation nightmare, the city has grown and continues to modernize it's approach to transportation.
