Honorable Councilmembers,

As an Angeleno who utilizes many different forms of transportation to get around town, I write to express my opposition to a recent proposal within the City of LA Task Force Committee's recommendations for Metro's 2015 Call For Projects, "Pedestrian Improvement" #1: "North Figueroa Great Streets Corridor - Phase 1." The proposed plan to reconfigure N. Figueroa Street between Ave 55 & Ave 60 with diagonal parking is ill conceived, and would be detrimental to the safety of both drivers and people on bicycles on N. Figueroa.

Addition of unneeded surface parking to this area will only congest the area by prioritizing travel by car, and limit access for bus riders and bicycle commuters. This is not a project worthy of taxpayer money or City Council support.

Besides the fact that the area has an excess of available surface parking, N. Figueroa is also a part of the 2010 Bicycle Plan, and incorporation of diagonal parking spaces would prohibit needed bike lanes for the safety bicycle commuters. The Northeast L.A. community has consistently expressed unwavering support for a "Figueroa For All," supportive of the needs of bicyclists, pedestrians, and transit users. This proposal flies in the face of that community voice and was been developed exclusive of community input.

The proposed project – which excludes the needs of cyclists for safe mobility – does not meet Caltrans' definition of a Complete Street: "A transportation facility that is planned, designed, operated, and maintained to provide safe mobility for all users, including bicyclists, pedestrians, transit vehicles, truckers, and motorists." Thus the project does not meet Metro's Complete Streets Policy adopted in October of this year.

Please re-scope this project application to represent a Complete Street incorporating accommodations for people on bicycles, or remove it from the Task Force list to ensure that proposed projects are in-line with community needs, city planning efforts, and regional complete streets policies.

I thank you in advance for your consideration, and for standing up for the quality of projects submitted for Metro funding.



**Proposed Applications to Metro 2015 Call for Projects
Lack of Consistency with Los Angeles General Plan
CF# 14-1680**

Dear President Wesson and Council Members,

The Los Angeles County Bicycle Coalition (LACBC) is generally supportive of the list of proposed projects to apply in Metro's 2015 Call for Projects. Overall, the list represents a city that is forward-thinking and developing projects that are consistent with complete streets and LADOT's new Vision Zero goal to eliminate all traffic fatalities in the city by 2025. LACBC particularly appreciates the emphasis on protected and low-stress bikeways, as well as the incorporation of complete streets into the RSTI and Goods Movement projects.

Unfortunately, LACBC must also point out one project that is glaringly inconsistent with the draft Mobility Plan 2035 and adopted 2010 Bicycle Plan, both of which were supposed to be screening criteria for the project list. The "North Figueroa Great Streets Corridor – Phase 1" project (Ped Improvements #1, page 5) is located along the Bicycle Plan's Backbone Network as well as the Mobility Plan's Bicycle Enhanced Network. The Backbone Network is characterized by Class II bike lanes while the Enhanced Network is designated to include protected bike lanes. Neither of these bikeway types is included in the proposed project scope on North Figueroa. These inconsistencies leave the project subject to CEQA challenge, if awarded funding.

Metro's new Complete Streets Policy defines complete streets as those that serve "all categories of users, including pedestrians, users and operators of public transit, bicyclists, persons with disabilities, seniors, children, motorists, users of green modes, and movers of commercial goods...within an integrated transportation network." Metro will evaluate individual projects against those city planning documents that define the layered, multi-modal transportation network—namely the draft Mobility Plan's enhanced networks for transit, bicycles and vehicles. This project, which proposes to reconstruct curbs and pavement without incorporating the bikeway required by the city's transportation plans, is unlikely to comply with this policy.

North Figueroa is the heart of Highland Park's historic business district and also a key facility in the citywide bikeway network, which is only as useful as the sum of its parts. These improvements would be highly complementary—bicycle improvements have been shown in cases from across the country, indeed the world, to promote vibrant local retail districts. The available local data suggests North Figueroa is primed for growth in bicycle ridership. In fact, the street already has



among the highest bicycle use of any street in Northeast Los Angeles—higher even than streets that already have bike lanes. Unfortunately on Figueroa, approximately half of these bicyclists are currently riding on the sidewalk through the business district. This is an unsafe condition for both the people riding and the people walking in and out of the many local shops that line Figueroa, which this project would only exacerbate as it makes an already unsharable street even narrower with diagonal parking.

It would be inappropriate for the city to spend limited resources securing funding for projects that are not consistent with the city's own plans. This project's failure to incorporate planned complete streets elements threatens to undermine the careful compromises at the foundation of the Mobility Plan's multi-modal networks, which tempered the ambitions of the Bicycle Plan by focusing on a much more limited network of higher quality infrastructure. The citywide significance of this issue is made all the more evident by the citywide response from your constituents included in this council file.

Everyone agrees that North Figueroa is in critical need of improvements. LACBC has worked extensively with community stakeholders to advance safety improvements for the entire length of North Figueroa for half a decade, participating in every planning process and project development workshop. LACBC would be proud to support a project in this location that respects the community's vision of a "Figueroa for All" and truly serves all who live, work and visit Highland Park. Until this project is re-scoped to align with this inclusive vision and to be consistent with the City's general plan, LACBC is compelled to register its opposition to the project with both the City and Metro. LACBC encourages the City to remedy these issues by including the missing project elements or removing this project from the Call for Projects application list.

No. We cannot imagine such a scenario.

But the killer exists - a street that provides a vital corridor from Silver Lake, Echo Park, Atwater and other areas to downtown that has been poorly designed and constantly places pedestrians and cyclists in danger.

There are extremists out there - those who say we should not care about those killed, those who say we should not worry about those injured. They say that there is only one priority: move more cars faster.

Los Angeles cannot stand by the status quo. We have blown away so much of the smog, cleaned up so much of the city, used smarter policing to reduce so much of the crime. And we have a plan to make the city so much less congested.

That's a plan the city approved. I went to outreach meetings. I watched it evolve. The city embraced Complete Streets. The city embraced a bicycling plan for which it should be rightfully proud.

Every year, I visit New York City. Who would have thought that I, a father, would feel safe putting my son on a bike in midtown Manhattan and riding beside him to Flushing Meadows in Queens. But the entire ride was on streets made safe for cycling.

Right now, I would not take my son to ride from Silver Lake down Figueroa to the vibrant downtown he so loves. Not until the killer is reigned in.

Those pushing against the future just want one little crack in the plan, one precedent to unspool all that hard work.

Figueroa is like those first murals testing the ban on advertising. There he was - an American soldier on the side of a building, the owner daring the city to force that patriotic mural to be ripped down. And when the city didn't force that, he was soon selling the building side as advertising space. And the chaos continues. That is why you make a long-term plan and you stick with the plan.

In this case, it isn't just outraged neighbors and real estate magnates. It is lives. Honest to God human lives.

No one wants one more single pedestrian or cyclist crash on N. Fig. I know this. You know this. But you have the chance to re-endorse the plan that reduces that risk the most. This is a contentious issue. The odds are there will be about 80 pedestrian and cyclist injuries on N. Fig in 2015...and one fatality. Do you want to vote with those odds, or vote to reduce those odds? That's the question. The answer should be simple. I hope none of you ever face an election flyer that shows a brutally injured Angeleno and asks why you voted to keep N. Fig unsafe when you knew of the danger?

Vote for a safer LA. Vote against the extremists who want to preserve the danger. Vote to put an end to grim track record of injury and death that has plagued N. Fig.

Honorable Councilmembers,

As an Angeleno who utilizes many different forms of transportation to get around town, I write to express my opposition to a recent proposal within the City of LA Task Force Committee's recommendations for Metro's 2015 Call For Projects, "Pedestrian Improvement" #1: "North Figueroa Great Streets Corridor - Phase 1." The proposed plan to reconfigure N. Figueroa Street between Ave 55 & Ave 60 with diagonal parking is ill conceived, and would be detrimental to the safety of both drivers and people on bicycles on N. Figueroa.

Addition of unneeded surface parking to this area will only congest the area by prioritizing travel by car, and limit access for bus riders and bicycle commuters. This is not a project worthy of taxpayer money or City Council support.

Besides the fact that the area has an excess of available surface parking, N. Figueroa is also a part of the 2010 Bicycle Plan, and incorporation of diagonal parking spaces would prohibit needed bike lanes for the safety bicycle commuters. The Northeast L.A. community has consistently expressed unwavering support for a "Figueroa For All," supportive of the needs of bicyclists, pedestrians, and transit users. This proposal flies in the face of that community voice and was been developed exclusive of community input.

The proposed project – which excludes the needs of cyclists for safe mobility – does not meet Caltrans' definition of a Complete Street: "A transportation facility that is planned, designed, operated, and maintained to provide safe mobility for all users, including bicyclists, pedestrians, transit vehicles, truckers, and motorists." Thus the project does not meet Metro's Complete Streets Policy adopted in October of this year.

Please re-scope this project application to represent a Complete Street incorporating accommodations for people on bicycles, or remove it from the Task Force list to ensure that proposed projects are in-line with community needs, city planning efforts, and regional complete streets policies.

I thank you in advance for your consideration, and for standing up for the quality of projects submitted for Metro funding.
