SUBJECT:	Resolution (Wesson – Huizar) to SUPPORT AB 88 (Gomez) Sales Tax Exemption for Energy/Water Efficient Appliances	

<u>CLA RECOMMENDATION</u>: Adopt Resolution (Wesson – Huizar) to include in the City's 2015-2016 State Legislative Program SUPPORT for AB 88 (Gomez) which seeks to establish a sales tax exemption for energy or water efficient home appliances, purchased by a public utility, that is provided at no cost to low-income participants in order to further energy and water efficiency objectives.

SUMMARY:

Resolution (Wesson – Huizar), introduced on May 13, 2015, states that existing state law calls for a sale tax to be imposed on retailers for the privilege of selling tangible personal property. The Resolution follows that AB 88 (Gomez), introduced January 7, 2015, seeks to establish a sales tax exemption for energy or water efficient home appliances, purchased by a public utility, that is provided at no cost to low-income participants in a federal, state, or ratepayer-funded energy efficiency program.

The Resolution indicates that AB 88 also seeks to provide that any amounts that would have been paid as sales tax by the public utility, should be used to purchase additional energy or water efficient home appliances to be provided to low-income participants.

The author of the measure maintains that AB 88 will help further the state's environmental goals by reducing energy and water consumption, while facilitating access of these products to a greater number of low-income participants.

The Resolution follows that the City's Department of Water and Power (DWP) conducts an energy efficiency program that supports the use of energy and water efficient home appliances for residential customers.

The measure would allow the DWP to provide a greater number of energy and water efficient home appliances to low-income participants thereby furthering the City's energy and water efficiency objectives. Therefore, the Resolution requests that the City support AB 88.

BACKGROUND:

Following a 2014 audit conducted by the Board of Equalization (BOE), it determined there is no exemption for energy or water efficient appliances purchased by public utilities and provided, at no cost, to qualified low-income customers participating in energy efficiency programs. As a result, the BOE established a sales tax for these appliances.

The author of the measure believes appliance replacement programs already serve too few of those who qualify, and an additional sales tax only weakens the effectiveness of energy efficiency programs.

The state's Energy Savings Assistance Programs (ESAP) provide no-cost services to low-income households to improve energy efficiency, such as weatherization and insulation. Certain ESAP customers may also be eligible to receive energy-efficient replacement appliances - when older units are either too old or inefficient to repair, or when those units are unsafe.

The author notes ESAP helps reduce energy and water consumption while lowering utility costs for low-income customers. The program also fosters safer recycling of older appliances, helping to reduce illegal dumping and ensuring hazardous components are handled properly.
