HOUSING COMMITTEE REPORT relative to the 2015 Community Services Block Grant (CSBG) award.

Recommendations for Council action, SUBJECT TO THE APPROVAL OF THE MAYOR:

1. AUTHORIZE the General Manager, Los Angeles Housing and Community Investment Department (HCIDLA), or designee, to:
 - a. Accept, on behalf of the City of Los Angeles, the 2015 CSBG award from the State of California (State), Department of Community Services and Development (CSD).
 - b. Execute and return to the CSD the signed CSBG contract with the required supporting documentation, subject to review by the City Attorney as to form.
 - c. Execute any subsequent amendments to the CSBG contract, subject to City Attorney review.

2. APPROVE the use of CSBG funds to operate the FamilySource Center System for the period of January 1, 2015 through December 31, 2015 as follows, subject to State appropriations of 2015 CSBG funds:

FamilySource Center System (1/1/2015 - 3/31/2015)	\$1,162,608
FamilySource Center System (4/1/2015 - 12/31/2015)	<u>\$3,601,720</u>

	Total: \$6,112,576

3. AUTHORIZE the Controller:
 - a. Establish new accounts within the CSBG Fund No. 428, and appropriate as follows:

<u>Account</u>	<u>Title</u>	<u>Amount</u>
43L261	FAMILYSOURCE SYSTEM	\$1,162,608
43L262	FAMILYSOURCE SYSTEM	\$3,601,720

 - b. Establish a receivable from the CSD in the amount of \$6,112,576 within the CSBG Fund No. 428.

4. AUTHORIZE the General Manager, HCIDLA, or designee, to prepare any Controller instructions needed to implement actions approved by the Council and Mayor on this matter, and/or to make necessary technical adjustments, subject to the approval of the City Administrative Officer; and, AUTHORIZE the Controller to implement the instructions.

Fiscal Impact Statement: The HCIDLA reports that there is no impact to the General Fund.

Community Impact Statement: None submitted.

SUMMARY

At its regular meeting held on January 14, 2015, the Housing Committee considered a report from the HCIDLA dated December 22, 2014 relative to approval of the 2015 CSBG award and related actions.

After providing an opportunity for public comment, the Committee approved the recommendations in the HCIDLA report. This matter is now forwarded to the Council for its consideration.
