El viernes 22 de agosto de 2014, aproximadamente a las 6:20 p.m., Beni Crump, Jr. de 17 años de edad, estaba cerca de Normandie Avenue y West Gage Avenue en Los Angeles, cuando fue perseguido por un sospechoso hacia Raymond Avenue y Gage Avenue. 
