KEN EHRLICH

Biography

Ken Ehrlich is one of the outstanding producers of music related and non-traditional programming for television with hundreds of hours of highly acclaimed specials to his credit, from the annual Grammy Awards, which he has produced since 1980, to a yearly slate of award shows including five Emmy Awards telecasts, as well as single and multi-artist and concept specials for network, cable, syndication and home video programming.

From his earliest days in television as the producer/creator of the award winning SOUNDSTAGE series for public television, which has been recognized as the forerunner of numerous types of "Unplugged" and reality type programming, Ken has continually been on the cutting edge of programming which has set the tone for others to follow. In fact, in early 2007, Ken was honored by the Producer's Guild of America with its "Visionary Award".

In his more than 30 years as a producer/creator, Ken has introduced numerous innovative concepts for shows ranging from the Grammys, the Emmys, the Blockbuster Awards, the Alma Awards, the Latin Grammys, the European MTV Awards, and the MTV Movie Awards, which he created in 1992.

He has produced dozens of single artist specials for broadcast and cable networks, including shows with Elton John, Celine Dion, Eric Clapton, Faith Hill, Shania Twain, Aretha Franklin. The Backstreet Boys, NSYNC, Ricky Martin, Marc Anthony, Paul Simon, Gloria Estefan, Barry Manilow, Christina Aguilera, Whitney Houston, The Bee Gees, Ringo Starr, The Eagles, etc.

He has been responsible for some of television's most memorable moments in shows ranging from Sports Illustrated's 20th Century Sports Awards (CBS) which brought together the single greatest collection of living athletes in history, to great collaborative moments on a series of DIVAS shows he created for VH1, to the historic Night For John Lennon and New York City, produced just two weeks after the events of September 11, 2001 as well as the LIVE8 show from Philadelphia.

He has also been involved in the creation and production of numerous music related series including Motown Live, The Dennis Miller Show, and for two years, produced the landmark series, FAME. In the late 80's, he introduced SHOWTIME COAST TO COAST, a memorable series of 'on the road' shows that featured superstar talent picked up from various locations around the country.

He has produced event specials all over the world and worked in venues as intimate as small clubs holding 150 people to 1997's ROCKFEST done at Texas Motor Speedway before a crowd of 350,000 people and the live NFL KICKOFF SPECTACULAR with Bon Jovi, Enrique Iglesias and Alicia Keys in front of 400,000 people in New York's Times Square.

Among his personal memorable moments is a continuing series of specials done for LIFETIME TELEVISION, "WOMEN ROCK: GIRLS WITH GUITARS" which have brought together some of the brightest female performers in music in concerts done for the breast cancer cause, and a number of INTIMATE PORTRAITS of female musical artists also for LIFETIME.

Over the years he has also been involved in numerous charitable benefits including those for the Entertainment Industries Foundation, The City of Hope, an epic seven hour show, "WELCOME HOME", a benefit for Vietnam Vets produced live at Washington's Capitol Centre and featuring a host of superstar artists, and three colon cancer fund raisers in New York (for Katie Couric) that featured stars such as Robert DeNiro, Bette Midler, Whoopi Goldberg and others. His long time love for the city of New Orleans and its music recently led him to produce a mammoth six hour all star benefit at Madison Square Garden for Katrina Relief, and the re-opening of the Superdome for football as the Saints emerged triumphant after an incredible performance by a combined U2 and Green Day.

He is most proud of his continuing relationship with much of pop music's royalty, including Celine, Eric Clapton, Elton, U2, Stevie Wonder, Beyonce, Alicia Keys, Bruce Springsteen, Kanye West, Paul McCartney and others who have called on Ken numerous times to work with them on various television projects. These long term relationships with artists are based on Ken's acknowledged understanding of music and the trust that this understanding was founded on over years of working with artists from their first television appearances on.

Ken and his wife, Harriet, live in Encino on a three-acre complex, which also serves as the home base for his operation. They have two grown children, Matt and Dori.
