Stella T. Maloyan is the Development Director at the Los Angeles Alliance for a New Economy, where she has overseen the organization's private fundraising program since 2002. Stella also created LAANE's two annual marquee events, the City of Justice Awards Dinner and the Women for a New Los Angeles Luncheon. The City of Justice Awards Dinner has become the premier progressive event in Los Angeles, bringing together 1,000 attendees from the labor, environmental, political, and entertainment sectors, while the Women for a New Los Angeles Luncheon attracts over 500 attendees for a unique and diverse gathering of women from all across the city. Under her leadership, LAANE has also developed Inter-Act, a membership program with the objective of outreach to a broad base of activists with the focus on the young Hollywood.

Stella has a Master's degree in Public Administration, a Bachelor's degree in Political Science, and Certification in Advanced Fundraising. She was a past board member at the humanitarian organizations Armenian General Benevolent Union and Program for Torture Victims. Stella is currently a board member at the Getty House Foundation, which oversees the Los Angeles Mayor's official residence and its programming. Stella is the co-founder of Women's Investment Network. Fluent in Armenian and Farsi, she was born in the U.S. and grew up in Iran.

Under separate cover you will be receiving a packet from the City Ethics Commission containing information about the City's conflict of interest laws and a copy of the State Form 700/Statement of Economic Interests. You are required to complete and return this form **within 21 days** of your nomination to the City Ethics Commission, 200 North Spring Street, City Hall, 24th Floor, Los Angeles, California 90012. 

Cary Gross will assist you during the confirmation process if you have questions.

Commissioners must be residents of the City of Los Angeles. If you move at any point during your term, have any changes in your telephone numbers, or in the future plan to resign (resignation must be put in writing), please contact my office immediately.
