HOUSING COMMITTEE REPORT relative to the Affordable Housing and Sustainable Communities (AHSC) Program.

Recommendations for Council action, as initiated by Motion (Bonin for Cedillo - Buscaino):

1. INSTRUCT the Los Angeles Housing and Community Investment Department (HCIDLA) to report on the recently approved AHSC Program regulations, the application process, and the process by which the City of Los Angeles may recommend projects for funding.
2. INSTRUCT the HCIDLA and the Chief Legislative Analyst (CLA) to coordinate a working group with all relevant City departments, and report.
3. INSTRUCT the CLA and the HCIDLA to report on the prioritized projects.
4. INSTRUCT the CLA, in conjunction with the HCIDLA, to negotiate a Memorandum of Understanding between the Southern California Association of Governments and the Los Angeles County Metropolitan Transit Authority relative to moving forward.

Fiscal Impact Statement: Neither the City Administrative Officer nor the CLA has completed a financial analysis of this report.

Community Impact Statement: None submitted.

SUMMARY

At its regular meeting held on January 28, 2015, the Housing Committee considered Motion (Bonin for Cedillo - Buscaino) relative to a report from the HCIDLA on the recently approved AHSC Program regulations, the application process, and the process by which the City of Los Angeles may recommend projects for funding.

The HCIDLA General Manager addressed the Committee on the matter and responded to related questions. The Committee Chair read into the record amendments to the Motion relative to various instructions to the HCIDLA and the CLA.

After providing an opportunity for public comment, the Committee approved the Motion as amended. This matter is now forwarded to the Council for its consideration.
