# A PROPOSED GENERAL PLAN AMENDMENT AND ZONE CHANGE FOR PROPERTY 6724 N ALLOTT AVENUE WITHIN THE VAN NUYS/NORTH SHERMAN OAKS COMMUNITY PLAN.
