

ORDINANCE NO. 184834

An ordinance establishing the *Miracle Mile Historic Preservation Overlay Zone* pursuant to the provisions of Section 12.20.3 of the Los Angeles Municipal Code (the Code) and amending Section 12.04 of the Code by amending the zoning map,

**THE PEOPLE OF THE CITY OF LOS ANGELES DO ORDAIN AS FOLLOWS:**


**Section 1.** Pursuant to Section 12.20.3 of the Los Angeles Municipal Code, the Miracle Mile Historic Preservation Overlay Zone is hereby established for the properties located within the shaded borders of the zoning map depicted below.

**Section 2.** The Zoning Map referenced in Section 12.04 of the Los Angeles Municipal Code is hereby amended by changing the zone for the properties located within the shaded borders of the zoning map depicted below to R-1-HPOZ, R1-1-O-HPOZ, R2-1-HPOZ, R2-1-O-HPOZ, R3-1-HPOZ, R3-1-O-HPOZ, RD1.5-1-O-HPOZ, C2-1-O-HPOZ, (T)(Q) C1-1VL-O-HPOZ

AS AMENDED BY THE PLANNING AND LAND USE MANAGEMENT COMMITTEE ON 12/14/2011

ALL ZONES IN THE AFFECTED AREA REMAIN IN THE SAME SUFFIX HOOD. REMAINING ZONES ARE RENAMED AND INCLUDED IN A HISTORIC PRESERVATION OVERLAY ZONE.


