I am currently renting at 1016 Masselin Ave. in the beautiful, irreplaceable chateau style building south of Olympic. I formerly owned 801 Masselin for a decade. I love this neighborhood, and feel so much gratitude for the plan to preserve its wonderful historic character. As we witness in many places around the city, the newer construction is usually inferior in every way to the older homes that are so much a part of LA's architectural charm.

As a realtor, I sold a home on South Ogden to a buyer recently. I'm noticing that the odd exclusion of the historic zone on Orange Grove south of Olympic could adversely affect his property and investment. The 4 story buildings that are being built would be a harsh blow to his property value and quality of life. I strongly favor extending the zone south to include that whole block down to Olympic.
