As a resident of 1215 South Orange Dr. I am writing to show my support for HPOZ. I have lived in my house for 13 going on 14 years and in that time I have been so happy with how historic and beautiful not only the neighborhood and my house are, but also how each of my neighbors has been a constant. We have such a community here in the Miracle Mile (and just south) area— there is so much support and camaraderie. I know other neighborhoods do not have this kind of bond that has lasted years and years, because none of us is either forced out (God forbid) by greedy landlords or wants to leave.

My house was built in 1927 and is a gorgeous English Tudor-style duplex. Between the archways, the hardwood floors, the garden out back, and the dark-stained doors, you'd be hard-pressed to find anything so steeped in history and echoing of old Hollywood anywhere. I would not feel at home in any other place in the city. The sloping hill of the front-yard, the carport, the old bricks in the sunshine— one should never replace this with a weird modern-looking high-rise and kick all of us out. It would be a sin. I know more about the history of this house than anyone. It needs to be preserved.

When there is no longer character or charm or camaraderie or respect for a neighborhood, that's when communities dissolve. That's when we feel more like part of a rat-race than part of a group of people. HPOZ is important to maintain the integrity and dignity of this neighborhood and keep it affordable for me to still live here.
