Our neighbor has shared with us a copy of Mr. Wesson's revised letter dated February 8th concerning the proposed HPOZ for the Miracle Mile. We live at 1235 South Orange Drive and we urge you to approve the HPOZ without any chances to the boundaries.

We are dismayed, however, that we have not received <u>either</u> Mr. Wesson's first letter nor the revised letter. We want to make sure that you will protect the wonderful quality of life in our neighborhood:

- its close community ties,
- · the rent-stabilized homes,
- · it architectural integrity, and
- especially its social and economic diversity.

Thus we strongly object to the suggestion that the HPOZ will be rejected if the members of PLUM and other city officials do not hear from those who live in the area. That presumption in favor of the developers who want to destroy our community with expensive, high-rise apartments is all the more outrageous and indefensible if none of the letters from Mr. Wesson are not even being delivered to the neighborhood!
