3. Motion to approve Board meeting minutes of February, 2015 made by C. Ferreyra, second C. Samson. Approved with corrections. One abstention (M. Denis).
4. L.A.P.D. Senior lead officers reports;
  - a. Van Nuys Division – Officers Paschal and Underwood.
    - i. Aggravated assault and crime in general is ticking up as well as Theft from Vehicles. Vanowen Blvd is especially vulnerable to stolen cars and tagging.
    - ii. Board member J. D'Antonio reported a car trespassing temporary traffic barriers ruining a newly repaved street near her house.
  - b. North Hollywood Division – Officers Duvally and Smith.
    - i. Violent crime and crime in general is up. There is a need to increase Neighborhood Watch participation in the community.
    - ii. Officers are soliciting ideas to help combat domestic violence.
5. Government representative reports;
  - a. Introduction of Deputy City Attorney, Diego Edber, North Hollywood Neighborhood Prosecutor.
  - b. Talene Dermenjian, Field Deputy, Assembly Representative Adrin Hazarian, gave information on Women's Self-Defense Course and will have a Power Point presentation next Board meeting.
  - c. Nikki Ezhari, Field Deputy, CD2, suggested an "adopt a trash bin" program for Valley Glen businesses.
    - i. Board member J. D'Antonio mentioned city won't pick up old TVs with picture tubes, Nikki mentioned they will if informed of picture tubes.

Motion unanimously approved via roll call vote: 14 Yes, 0 NO, 0 Abstain, 2 ineligible.

  - a. Cheryl Cashman, Community Ambassador, American Red Cross, spoke on an upcoming Emergency Preparedness event and GVGC's role.

**Community Outreach and Neighborhoods Committee.**

- a. Motion to approve C. Ferreyra as Acting Committee Chair made by C. Ferreyra, second M. Jannol. Motion approved via voice vote.
- b. Update on website management and “approved” vendors.

**Government Relations Committee – J. Price, Chair.**

a. Motion stating that the Greater Valley Glen Council is opposed to the Draft Ordinance adding Section 22.818 to the Los Angeles Administrative Code establishing Regional Neighborhood Council Grievance Panels and granting the Board of Neighborhood Commissioners the authority to vacate Board seats made by J. Price, second C. Samson. Council File #150067.

Motion approved unanimously via voice vote.

PROPOSED COMMUNITY IMPACT STATEMENT: Since NCs are already required in the Bylaws to address grievances, the GVGC is opposed to the Draft Ordinance adding Section 22.818 to the Los Angeles Administrative Code establishing Regional Neighborhood Council Grievance Panels and granting the Board of Neighborhood Commissioners the authority to vacate Board seats. Grievances should be handled in the jurisdiction where filed. Neighborhood Councils should have parity with the City Council which has no such requirement regarding grievances. Imposing more rules and regulations on NCs further erodes their local control and self governance, and conflicts with the intent of the Charter. Council File #15-0067.

b. Motion stating that the Greater Valley Glen Council in spirit supports the Draft Ordinance adding a new Article 12 to Chapter 6 of the Los Angeles Administrative Code establishing a Sidewalk and Curb Repair Fund; however, it cannot support the Draft Ordinance until the source of funding is established and is acceptable made by J. Price, second C. Ferreyra.

Motion approved via voice vote.

a. Motion stating that the Greater Valley Glen Council is opposed to the Board of Neighborhood Commissioners (BONC) proposed Resolution to enter into contracts/agreements for online voting for the 2016 Neighborhood Council (NC) elections and the delegation to the Department of Neighborhood Empowerment (DONE) the ability to finalize and execute a contract/agreement on behalf of BONC. The GVGC strongly urges that NCs be given an appropriate amount of time to review this proposal before anything is decided by BONC and DONE. NCs should be able to make self determination on whether to use online voting and should not be an unilateral mandate made by C. Ferreyra, second by D. Breidenbach.

Motion approved via voice vote.

b. Motion for the expenditure of no more than \$500.00 to co-sponsor a Senior Symposium March 22 presented by ONEgeneration for community seniors. The Symposium will address senior issues and normally draws an average of 800 senior stakeholders. GVGC will have a booth at the symposium as an outreach opportunity made by C. Ferreyra, second D. Breidenbach.
