DISCUSSION

The Los Angeles Police Foundation will provide the Los Angeles Police Department (Department) with 21 crime scene preservation canopies. The canopies will be distributed to each of the geographic Areas under Operations-Central, West, and Valley Bureaus, including the Department's four traffic divisions. The canopies will benefit the Department by assisting investigators in the preservations of evidence at crime scenes and by helping preserve the dignity of the victims and their families.


In the event that the canopies become damaged or need repair the canopy frames are warrantied for eight years and the graphics for three years. No expressed or implied commitments or promises were made to the donor or representatives of the donor. The donor will not receive any preferential treatment, endorsement, or recommendation; and the donor is not allowed the use of any Department patents.

Administrative Services Bureau has reviewed the donation and determined that it has been submitted in accordance with Section 5.467 et seq. of the Los Angeles Administrative Code, which provides for the receipt and acceptance of donations to the Department.
