The donation is for the benefit of the Los Angeles Police Department (Department) and the City of Los Angeles (City). The Los Angeles Police Foundation will provide the equipment to augment the Family Justice Center (FJC) at the Department's North Hollywood and Mission Areas. As part of the initiative, the Department will also work in collaboration with forensic nurse examiners from Northridge Hospital, Center for Assault Treatment Services, advocates from Strength United, and Jewish Family Services to develop and implement a comprehensive community outreach and education program that focuses on victim wellness and safety planning. The approval of this donation benefits the City by providing immediate crisis intervention and emergency assistance for the victims at the onset of the abusive event and continues throughout the investigative and judicial process. It increases victim safety and victim cooperation from the initial investigation through prosecution. Furthermore, it decreases recidivism and improves the perception of the Department by domestic violence victims.

On July 24, 2015, Karen Bottancino, Information Technology Bureau, approved the equipment for use by the Department. The equipment will be maintained and supported by the FJC lead agency, California State University at Northridge, and Strength United.
