SUBJECT: APPROVAL OF DAYS OF DIALOGUE DONATION

It is requested that the donation for \$30,000 be approved and made available to be utilized in conjunction with the partnership for Days of Dialogue. The background for the Days of Dialogue workshops are to recognize our history and how we have grown as a law enforcement entity and as a community since 1965, when the Watts riots took place. With this backdrop and the need for this national discussion at the local levels, the Los Angeles Police Department, (LAPD) has committed to hosting workshops to encourage open communications in efforts to gain mutual understanding of one another. Clearly there is a disconnect whether real or perceived between the police and the community, so in an effort to connect with communities we serve while gaining trust by building relationships, the LAPD will host these workshops for the next twelve months.

We hope to strengthen the relationship so we build and create new ones as well. With consistent open dialogue it is our desire that we create a sense of accountability from the community and the LAPD in an effort to work together to build lasting relationships.

LAPD hosted four workshops throughout the month of August and will now be followed by one workshop each subsequent month for a total of 15 ending in August 2016. The \$30,000 donation will be split evenly between each host division. Participants will include Los Angeles Police Senior Lead Officers, Command Staff and Community Relationship Division officers and supervisors. This program also will allow the Department to collaborate and invite partner agencies including Los Angeles Fire Department, California Highway Patrol and The City Attorney's Office.

The workshops can be as large as 150 people but on the average the groups are expected to be about 100 attendees. The funds requested are to provide light refreshments and beverages for each workshop held. The Los Angeles Police Foundation has agreed to reimburse host divisions directly.

# DAYS OF DIALOGUE



- What the Days of Dialogue event looks like:
  - Host introduces self and hosting organization (i.e., LAPD and LAFD co-hosting, LAPD OWB)
  - · Host then hands it off to the lead facilitator
  - Lead facilitator speaks and introduces Days of Dialogue Organization, program and instructions for both whole group and smaller group interactions
  - Each smaller group is provided questions and research/data to facilitate educated conversations founded on personal belief, and data provided
    - o Smaller groups consist of individuals seated at tables
    - o There should be at minimum one officer seated at each table
    - o There will be a minimum of one facilitator at each table
  - The idea is to ensure everyone's concerns/ideas are brought up
  - Smaller group dialogue is then brought together, by the lead facilitator, as a whole group where small group conversations are shared with the room
- What do we need to do as the Host?
  - Captains and Senior Lead Officers should attend
  - Provide light refreshments (not formal meals)
  - Secure a venue
    - o Ensure venue can accommodate 'round table' style setup for small work groups
  - Ensure community members are invited
  - Communicate # of invitees to Days of Dialogue (Jill Frank) to ensure sufficient facilitators are assigned
  - Attempt to invite neighboring agencies (i.e., LASD, LAFD, CHP, School PD)
  - Consider inviting other important officials/departments (i.e., Councilmembers, DCFS)
  - · Consider posting signage that states you may be recorded during this event
  - Ensure accommodations are made for Audio/Visual (A/V tech will be provided by Days of Dialogue for workshops of 100+ attendees)
  - Identify individuals during event who can be pulled aside for media comment (Command Staff, officers, community members)
- Funding
  - Captain Ruby Malachi has acquired a grant through the Police Foundation which will provide approximately \$1200 per workshop
    - o Capt Malachi will follow up with each Area specifically to discuss acquiring the funding
- · What do we do with the information gathered throughout the Dialogue?
  - Pre/Post surveys will be conducted by Days of Dialogue subsequent data will be provided to the host
  - Be prepared to host a follow up event
    - o Any actionable items or topics that should be followed up on
    - o Consider hosting a follow up townhall to address concerns
    - Follow up can be provided through connection of resources, CPAB meetings, Neighborhood Meetings, Community Forums



# DAYS OF DIALOGUE

  - LAPD has made a commitment of hosting one event monthly throughout 2015 and into 2016
    o Future scheduling will be discussed at a later date
  - All events are organized to engage community stakeholders and members of law enforcement in safe settings that are conducive to honest dialogue between the parties
  - Days of Dialogue will bring their 'program' (trained facilitators and dialogue guides, with 1-2 facilitators per table of 8-10 participants)
  - Dialogues typically range in size from 20-200
    - o This includes all attendees (community members, officers, facilitators)
  - Hosts have an opportunity to submit questions(data, graphs, images, quotes) before event
    - o A tentative list has been provided from Days of Dialogue
    - o Please send any info ASAP to Jill Frank
  - All Bureaus are scheduled to host the initial 'kickoff' event on August 11<sup>th</sup> at varying times and locations
  - The 'kickoff' events are scheduled on Aug 11 to recognize the 50<sup>th</sup> anniversary of the Watts riots (8/11/65)
    - 0 Nothing will be done to commemorate riots, just a way of recognizing the history
  - Manifest Justice Slideshow of artwork will be shown at the event (manifestjustice.org)
