EXPRESING SUPPORT FOR HOUSING FOR HEALTH WITHIN THE LOS ANGELES HOMELESS POPULATION

December 14, 2015

Whereas, 25,686 people are homeless in the City of Los Angeles, 17,687 of which are unsheltered; and

Whereas, homelessness can be a cause and result of serious health issues, often detracting from regular medical attention, access to treatment, and recuperation; and

Whereas, a study conducted by Michael R. Cousineau, associate professor of preventive medicine at the Keck School of Medicine of USC, found that the total cost of public services spent on four individuals during two years living on the street in Los Angeles was \$187,288, a cost which dropped by more than \$20,000 per person during two subsequent years spent in stable, permanent housing; and

Whereas, the New England Journal of Medicine published a study concluding that homeless people spent an average of four days longer per hospital visit than comparable non-homeless people; and

Whereas, a study of hospital admissions of homeless people in Hawaii revealed that 1,751 adults were responsible for 564 hospitalizations and \$4 million in admission costs with estimates that the excess cost for treating these homeless individuals was \$3.5 million; and

Whereas, the County of Los Angeles Housing for Health program has been successful in housing over 1,000 people experiencing homelessness in Los Angeles through a combination of housing programs, including a Flexible Subsidized Housing Pool.

Therefore, be it resolved, that the City of Los Angeles Health Commission supports the Housing for Health model as one critical step toward addressing the health and mental health care needs of the City of Los Angeles Homeless population as well as the public health of the community; and

Therefore, be it further resolved, that a copy of this resolution be sent to the Mayor of Los Angeles and the Los Angeles City Council.
