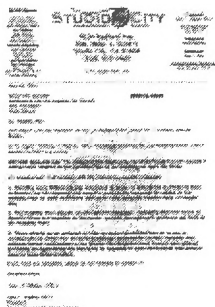

Dear Mayor Garcetti, Members of the Los Angeles City Council, Mr. Torossian, and Ms. Bowen,

At its regular meeting on May 21, 2014, the Board of the Studio City Neighborhood Council passed the following motion:

**MOTION 2014.05.12C:** The Board of the Studio City Neighborhood Council passed a motion with respect to the Mobility Plan at its meeting on April 16, 2014.

We supplement that motion with the following specific requests:

1. The Bike Lane Ordinance was amended to show no bike lanes on Ventura Blvd. in Studio City. We request that specific conforming language be added to the Mobility Plan to state that there will be no bike lanes on Ventura Blvd. in Studio City.
2. The Mobility Plan should contain specific language indicating that the terms of Specific Plans are superior to the goals, general concepts and guidance set forth in the Mobility Plan.
3. There should be no revisions to the current road dedications as to use or configurations within the Ventura/Cahuenga Boulevards Corridor Specific Plan without formal notification to the Studio City Neighborhood Council and without providing an opportunity for the SCNC to respond to such notification and make a case by case determination.
