 - c. Meridian Street from Avenue 46 to Avenue 66
 - d. Collis Avenue from Huntington Drive to the South Pasadena city limit
 - e. Campus Road from Westdale Avenue to York Boulevard
 - f. Alumni Avenue from Eagle Rock Boulevard Campus Road
- C. Convert from Bicycle Lane Network and designate as Bicycle Enhanced Network on:
 - a. Monterey Road from Via Marisol to Avenue 60
 - b. Olympic Boulevard from Lorena Street to Soto Street
 - c. Valley Boulevard from the Alhambra City Limit to Soto Street
- D. Designate as Planned Priority Bicycle Lane on:
 - a. Mission Road from Cesar Chavez Avenue to Jesse Street
 - b. Eastern Avenue from Huntington Drive to Valley Boulevard
 - c. Marengo Avenue from Soto Street to Fickett Street
 - d. Verdugo Road from Eagle Rock Boulevard to the Glendale city limit
- E. Designate as Planned Bicycle Lane on:
 - a. Alhambra Avenue from Eastern Avenue to the Alhambra city limit
- F. Extend existing Pedestrian Enhanced District on:
 - a. Colorado Boulevard from Glendale city limit to Pasadena city limit
 - b. Huntington Drive from Mission Road to Kendall Avenue
 - c. 4th Street from Alameda Street to the County of Los Angeles line
- G. Designate as Pedestrian Enhanced District on:
 - a. York Boulevard from Eagle Rock Boulevard to San Pascual Avenue
 - b. Santa Fe Avenue between Center Street and 7th Street
 - c. Mateo Street between Santa Fe Avenue and 7th Street

- d. Figueroa Street from York Boulevard to Colorado Boulevard
- e. 6th Street from Mateo Street to Mesquit Street
- f. Mesquit Street from 6th Street to Jesse Street
- g. Myers Street from Jesse Street to 7th Street
- h. Jesse Street from Mission Road to Clarence Street
- i. Clarence Street from 4th Street to Jesse Street
- j. Anderson Street from 4th Street to 7th Street
- k. Rio Street from Jesse Street to 7th Street
- I. 6th Street from Mission Road to Clarence Street
- m. Mission Road from 1st Street to Jesse Street
- H. Designate as a Comprehensive Transit Enhanced Network on:
 - a. Valley Boulevard from the Alhambra city limit to Soto Street
- I. Designate as a Moderate Transit Enhanced Network on:
 - a. Eastern Avenue from Huntington Drive to Valley Boulevard
