Dear Honorable Councilmembers:

I support adopting the Mobility Plan 2035, including ALL of its proposed networks. I'm a 59 year old corporate attorney, I bike commute daily the 10 miles from Pacific Palisades (where I live) to Century City (where I work). During rush hours, it takes about the same time to bike as drive this commute. I support this Plan because it will make L.A. streets safer for me and better for all of us. I'm counting on you, our citywide leaders, to adopt the Plan and encourage safer streets; if you do, others will join me and the growing numbers of bike commuters.

A well-connected network of protected bike lanes offered in the Plan is critical to the safety of bicycle commuters, and when the full Plan is implemented more workers will feel safe getting out of their cars and joining those of us already commuting by bike. Please don't piecemeal the Plan to appease local naysayers; that would undermine the citywide network of bike lanes utility and growth of bike commuting, and would jeopardize the lives of bike commuters. Please show your citywide leadership on this citywide issue and support the Plan.

A councilmember's recommendation to remove bike lanes on Westwood Blvd from the Mobility Plan 2035 alarms those of us who commute by bike or envision a more walkable and bikable City of Los Angeles. We need more safe bike lanes connecting popular destinations like Westwood Village and UCLA to neighboring communities—not fewer. The L.A. Department of Transportation (LADOT) reports that half mile stretch has more than 8 times as many collisions between vehicles and bicyclists than similar streets in Los Angeles. As a bike commuter, I would like to more frequently ride Westwood Boulevard for shopping and restaurant options but without proper accommodation for bicyclists, riding in Westwood continues to scare not just me but the many students and faculty I see riding with me in this area every day. Please keep the Plan's networks intact and keep Westwood Blvd. in the Plan. The plan will be good for Westwood business, Los Angeles commuters, and **it is literally a matter of life and death** for those of us on bikes.

Please approve the Mobility Plan 2035 so that we can all travel safely on the streets of L.A.

#### Support for Mobility Plan 2035 with No Amendments

Dear Councilmembers Huizar and Bonin and Committee Members,

The Los Angeles County Bicycle Coalition (LACBC) writes in strong support of Mobility Plan 2035 as currently drafted. The Mobility Plan is a forward-thinking, balanced approach to Los Angeles's transportation challenges and provides the necessary framework for strategic investment in our city's transportation system for the next two decades. We urge you to adopt the Mobility Plan with no changes.

The last comprehensive update to the circulation element was adopted in 1999. Since then, we have come to realize that transportation is at the root of so many of the city's challenges. Traffic collisions—the 4<sup>th</sup> leading cause of premature death in Los Angeles County—kill over 200 people in the city every year, with the highest rates occurring in low-income communities of color. Obesity, caused primarily by lack of physical activity and lack of access to healthy food, continues to rise while also disproportionately afflicting low-income communities of color. Our cars and trucks generate almost half of the city's greenhouse gas emissions responsible for climate change, which poses one of the greatest threats to our health, security and quality of life. Our transportation system is deadly, unhealthy and unsustainable.

As we face these unprecedented challenges, we also have unprecedented opportunities to build upon promising trends: we now have regular CicLAvias, everyday bike ridership has spiked and the voter-approved expansion of the region's transit system is rapidly under construction. Our streets are now seen as places for people, not just thoroughfares for cars. Technologies like real-time transit info, ride hailing apps and bike share promise to give Angelenos new tools to take full advantage of the new infrastructure being built. The Plan for a Healthy Los Angeles, adopted earlier this year, has grounded mobility conversations in the context of health and equity, recognizing that better transportation policy provides economic mobility for underserved residents while promoting community health and active transportation. Mayor Eric Garcetti's Sustainable City pLAn calls for increasing walking, biking and transit to 35% of all trips in just 10 years to help meet the city's greenhouse gas reduction goals. The LADOT Strategic Plan sets a goal of eliminating all traffic fatalities by 2025. The Mobility Plan embraces these challenges and opportunities by weaving together mobility, environmental, health and safety goals into a strong policy framework.

The plan before you was the result of years of thoughtful input, deep engagement and strategic compromise to achieve a balanced, multimodal network that puts safety first, while providing access, choice and reliable travel for all Angelenos. *It is critical that you maintain these carefully constructed networks in order to realize the benefits of this plan.* LACBC is deeply concerned about the efforts by a few vocal residents to jeopardize multimodal access to UCLA by removing the university from the proposed Bicycle Enhanced Network. An estimated 3,000 students, faculty and staff ride bicycles to campus every day for their commute, 800 of whom ride on Westwood Boulevard. There are currently no continuous bikeways to UCLA from the transit hub at Wilshire and Westwood or the soon-to-open Expo Line station on Westwood Boulevard south of Pico. Creating these multimodal connections is the primary means by which the Mobility Plan proposes to reduce congestion and increase transportation options. UCLA has been a tremendous partner in the city's efforts to reduce the number of commuters driving alone: 65 percent of students, faculty and staff already take alternative modes. Untangling gridlock on the Westside—and throughout Los Angeles—depends on the city doing its part to improve safety and convenience for people biking, walking and taking transit.

Maintaining the integrity of the proposed networks is a citywide imperative that requires leadership by City Council members that support multimodal transportation. Planning staff developed these networks in consultation with a wide range of stakeholders, as reflected by the broad support demonstrated for the Mobility Plan among business, environmental and community groups across the city. The City Planning Commission and Mayor Garcetti concurred with staff's recommendation to keep Westwood Boulevard in the Mobility Plan, despite Councilmember Koretz's request to remove it. LACBC urges you to agree with Mayor Garcetti, the City Planning Commission and staff by adopting Mobility Plan 2035 with no changes.

#### RE: OPPOSE Mobility Plan 2035 in current form

Dear Hon. Councilmembers,

The Cheviot Hills Homeowners' Association ("CHHOA") has serious concerns about the Statement of Overriding Considerations ("Statement") recently approved by the City Planning Commission for Mobility Plan 2035 ("MP 2035"). We are dismayed that, despite years of engagement and arduous efforts by our community and the Westside Neighborhood Council to get our issues included in the study, we have arrived, not with a plan, but with an absolute capitulation.

Regardless of money spent, time taken, professionals employed and lobbyists engaged, MP 2035 is an abdication of the Planning Department's responsibility to provide Los Angeles with a workable plan for more livable communities. This document does anything but, and its failures are clearly codified in the Statement which plainly says, "The MP 2035 Final EIR concluded that, despite the adoption of feasible mitigation measures, the MP 2035 would result in the following unavoidable significant adverse impacts which are not able to be mitigated to a less-than-significant level: transportation (circulation, neighborhood intrusion, congestion management plan and emergency access); noise and vibration (excessive noise from buses and permanent noise increase from buses); and biological resources (sensitive species/habitats, Wetlands)." Most troubling to CHHOA is the acceptance of additional delay to emergency first responders, increased traffic congestion, and the imposition of additional bike lanes on Westwood Boulevard.

CHHOA is anticipating the pending startup of the Exposition light rail in our area where Expo has "shoehorned in" three sequential at-grade crossings and two train stations within ½ mile. Like MP 2035, Expo says the trains will also add delay to first responders, but contend that the delay is acceptable. We know that LAFD response times on which Expo's environmental study relied were much longer than reported, so Expo's 280 daily street level crossings across Westwood Blvd. and Overland Ave. will have a much greater impact than projected. Is Expo's first responder delay still acceptable when combined with the additional significant and unavoidable delay of MP 2035? We say NO and hope that you will agree with us.

Further, MP 2035 fails where the 2010 Citywide Bike Plan also fails, namely in its omission of any analysis of the impacts of making changes to City streets in favor of bicycle traffic which represents less than 1% of all travel trips. In our area the Bicycle Enhanced Network (BEN) for Westwood Blvd. directly conflicts with the pathway of the new Expo light rail line. It also conflicts with the intention and operation of the Transit Enhance Network (TEN) bus which seeks to increase ridership by speeding up the buses through Westside streets.

The Expo Phase 2 light rail proposes to nearly double bus ridership along Westwood Boulevard in order to bring passengers to the Westwood Station. That station, which will handle over 5000 daily boardings (the highest on the line), has no patron parking. While there may be streets where lane reductions, parking removal and traffic calming are appropriate, such measures on major bus routes like Westwood Boulevard are counter intuitive to increased mobility and transit use. If a single bicyclist is allowed to impede a bus carrying 60 passengers to the light rail, then intelligent, efficient transit has not been achieved.

Expo projects significant new traffic congestion and increased air pollution around our two light rail stations. Because of Expo and the recent imposition of bike lanes replacing vehicle lanes, access to and from Cheviot Hills is increasingly limited for residents and emergency responders. How can our neighborhood, sitting at the crossroads of the I-10, the I-405 and the Expo light rail, safely endure the additional traffic and density encouraged by MP 2035 when we are already at the 99% level of traffic congestion and at the 89% for diesel particulates in our local air?

Residential density in Los Angeles metropolitan area already ranks second of all national metropolitan

areas. Our power grid is stressed and our water mains erupt daily all over the City. City services for our urban forest are vastly insufficient. Our sidewalks and streets are failing, and we are in a drought. MP 2035 provides no rationale for smoothing the way for additional density under those circumstances. This *stealth upzoning of 80 percent of the city*, and the resulting unmitigated environmental impacts, especially along the Expo corridor, is unjustifiable. To borrow from Yeats, surely "the centre cannot hold."

We hope that you will carefully consider the foregoing and act against the ratification of MP 2035 by the City Council to help preserve a safer and saner mobility future for our community.
