A PROPOSED ZONE CHANGE AND GENERAL PLAN AMENDMENT FOR PROPERTY LOCATED AT 233, 235, 243 WEST WASHINGTON BOULEVARD, 1841, 1843 SOUTH OLIVE STREET

Pursuant to the provisions of Sections 551, 555, and 558 of the City Charter, transmitted herewith is the March 12, 2015 action of the City Planning Commission <u>approving</u> a proposed General Plan Amendment to the Southeast Los Angeles Community Plan from the Light Manufacturing <u>to Community Commercial Land Use Designations for the subject property. The City Planning Commission also <u>approved</u> a Zone change request from M2-2-O <u>to (T)(Q)C2-2D for the proposed 160 residential units and 24,000 square feet of retail space.</u></u>
