FISCAL YEAR 2014-15 AB 109 FUNDS - PUBLIC SAFETY REALIGNMENT

RECOMMENDED ACTIONS

1. That the Board of Police Commissioners (Board) REVIEW and APPROVE this report.

- 2. That the Board TRANSMIT the grant award for the 2014-15 AB 109 Funds Public Safety Realignment, pursuant to Administrative Code Section 14.6(a), to the Mayor, Office of the City Administrative Officer (CAO), Office of the Chief Legislative Analyst, and to the City Clerk for Committee and City Council consideration.
- 3. That the Board REQUEST the Mayor and City Council to:
 - A. AUTHORIZE the Chief of Police or designee to ACCEPT the award of the 2014-15 AB 109 funds in the amount of \$3,076,440.50 from the Board of State and Community Corrections (BSCC) through the City of Gardena, for the period of July 1, 2015 through June 30, 2016;
 - B. AUTHORIZE the Chief of Police or designee to negotiate and execute the award agreement and submit any necessary documents relative to the grant award, subject to City Attorney approval as to form and legality;
 - C. AUTHORIZE the Controller to set up a grant receivable and appropriate \$3,076,440.50 to appropriation account, account number to be determined, within Fund No. 339, Department No. 70, for the receipt and disbursement of AB 109 grant funds;
 - D. AUTHORIZE the LAPD to submit grant reimbursement requests to the grantor and deposit grant receipts in Fund No. 339, Department No. 70;
 - E. AUTHORIZE the LAPD to spend up to grant amount of \$3,076,440.50 in accordance with the grant award agreement;
 - F. AUTHORIZE the Controller to increase appropriations as needed from Fund No. 339, Department No. 70, of the AB 109 Funds appropriation account number to be determined, to Fund No. 100, Department No. 70, account number and amount as follows:

Overtime, Sworn

\$2,812,101.42

G. AUTHORIZE the LAPD to prepare Controller instructions for any technical adjustments, subject to the approval of the CAO, and AUTHORIZE and INSTRUCT the Controller to implement the instructions.

DISCUSSION

The Los Angeles County Police Chiefs Association (LACPCA) received funding from the State of California, BSCC to enable front-line intervention services for Post-Released Supervised Persons (PSP). Based on a collective decision from the members of the LACPCA, each local law enforcement agency was allocated funds based on the current PSP population in their city.

The City of Los Angeles has approximately 33 percent of the entire PSP population in Los Angeles County. Currently, this population totals 4,313 PSPs. Based on these figures, the LACPCA has allocated \$3,076,440.50 to the Department. This is the third year of funding for the Department. The grant will pay for \$2,812,101.42 in sworn overtime for various programs, which will be distributed to geographical Areas and Metropolitan Division to supplement their fight against Part 1 crimes, specifically to conduct compliance checks involving Post-Released Supervised Persons as well as efforts to locate absconders. It will also be used for additional intervention services for the City's homeless and mentally ill populations. The remaining funds in the amount of \$264,339.08 will be allocated for training and equipment.

Per Chief Medrano the Department's portion of the 3rd year AB109 funding is \$3,076,440.50. Chief Medrano needs a single invoice from the Department in this amount and they will process the payment. The invoice method is the same as the previous years.

There is also an additional \$750,000 of funding that is designated for the Department that has been set aside by the LA County Chiefs. This amount is set aside to fund a portion of a three-year study on AB109 as well as the activities being identified by the subcommittee chaired by Chief McClure and attended by Detective Bureau focused on training in dealing with the mentally ill. The subcommittee is responsible for proposing the plan to the LA County Chiefs for approval. A total of approximately \$3 million has been set aside for this purpose (our portion is the \$750k).
