REQUEST FOR APPROVALTO EXECUTE A FIRST AMENDMENT OF LEASE WITH 110 SUNSHINE SMOOTHIES TO RELOCATE TENANT TO KIOSK SPACE 10C

The Department of General Services (GSD) requests authority to amend the lease agreement executed on June 22, 2016 between the City of Los Angeles and Fariba Atigehchi, dba 110 Sunshine Smoothies DRNK Coffee + Tea/Qwench Juice Bar (110 Sunshine Smoothies) located at 201 North Los Angeles Street, Space 10D, in Los Angeles, California.

BACKGROUND

Pursuant to Council File Number 15-0857 (Council action adopted on August 19, 2015) authorizing GSD to negotiate a new lease agreement with 110 Sunshine Smoothies), GSD is requesting authority to amend the 110 Sunshine Smoothies lease for the purpose of relocating this tenant from Kiosk Space 10D to Space 10C. Space 10C is more suitably equipped to operate a grab-and-go eatery. A fast food café was previously operated in the aforementioned space. Space 10C currently has the proper water supply plumbing installed in the site. Space 10D does not have any water supply to the kiosk. According to an estimate, to install the required water supply to Space 10D from P1, in City Hall East, would be guite costly.

This amendment is requested for the sole purpose of relocating the tenant from Kiosk Space 10D to 10C. All other terms and conditions will remain the same, as stipulated in the lease executed on June 22, 2016.



RECOMMENDATION

That the Los Angeles City Council authorize the Department of General Services to execute a first amendment to Fariba Atigehchi, dba 110 Sunshine Smoothies lease to relocate this tenant to Kiosk Space 10C, as substantially outlined in this report.
