Agenda Item 5 – Motion to support Council file 15-0937 (proposed zoning change to 5203 – 5205 Lankershim Boulevard)

The Executive Committee unanimously approved and forwarded to the full Board a motion to support Council File 15-0937, an effort to update the zoning for 5203-5205 Lankershim Boulevard. Mr. Braswell and Ms. Liebowitz Neglia reviewed the background on the property and the motion.
