#### Dr. Erica L. Jacquez DPPD Bio


Erica L. Jacquez has been dedicated to public service for more than 15 years. Currently, she works as the Associate Vice President of Government Relations for AltaMed Health Services. In November 2011, she was appointed by President Barack Obama to serve as the Intergovernmental Affairs and Public Engagement Liaison at the U.S. Department of Housing and Urban Development (HUD) under the leadership of Secretary Donovan. In this capacity, she served as the liaison for public engagement organizations and local elected officials. She later served as a Congressional Relations Officer at HUD for the West Region, where she worked with Congressional and Senate members on HUD related issues and policies. After this role, she served as a legislative analyst at the Office of Management and Budget's Legislative Affairs. In this capacity, she served as the lead coordinator for the President's Statement of Administration Policy. Prior to her work in the Obama administration, Erica served Los Angeles County Supervisor Gloria Molina as the First District Field and Unincorporated Services Director. In this role, she functioned as Molina's main community liaison and oversaw the Supervisor's satellite offices in East Los Angeles and the San Gabriel Valley. In addition, Erica held several leadership positions including Public Affairs Manager for the Southern California Gas Company, a Sempra Energy Utility and as the District Director for State Senator Martha Escutia serving the constituents of the 30th Senate District.

Ms. Jacquez recently received her Doctorate in Policy, Planning and Development from the University of Southern California (USC). She successfully defended her doctoral dissertation, "Latina elected officials in California. A call to action to prepare and pipeline Latinas into the political process." She is an expert in the field of Latinas in politics, Latina/o elected officials in California and Latinos in politics. She earned a Master Degree in Public Administration from USC in addition to receiving a certificate in Political Management. She also earned her undergraduate degree in Criminal Justice with a minor in Chicano Studies from California State University, Fullerton. She is a graduate of Harvard University's John F. Kennedy School of Government's Executive Leadership Program and the Center for Creative Leadership.

Ms. Jacquez served in various leadership roles including, the founding Co-Chair for the Latino Appointee Kitchen Cabinet and founding Co-Chair for the California Latino Caucus Institute's Madrinas Padrinos program. She also served as the inaugural chair for the University of Southern California Mexican American Alumni Association's Young Leaders Council. In 2014, Erica was selected Huffington Post's 40 under 40: Latinos in American Politics. Erica was awarded with the Mujerers Destacadas Award by La Opinión, the largest Spanish-language newspaper in the United States and second most read newspaper in Los Angeles, 2009. In 2004, she was appointed and served on the State of California's Domestic Violence Advisory Council

In 2013, Ms. Jacquez was selected to participant in President Obama's Inaugural Leadership Program. She was also selected to participate in the U.S. Spain Young Leaders Council, a graduate of the Hispanas Organized for Political Equality (HOPE) Leadership Institute and USC's Ross Program in Real Estate. She received political training from Emily's List, the National Women's Political Caucus and Rutgers State University of New Jersey. Ms. Jacquez is also a graduate of the National Hispana Leadership Institute and a graduate of the Valley Leadership Institute.

She previously served as a board member for the Economic Alliance and Planned Parenthood. She is very active in her community working as a volunteer on federal, state, and local campaigns. A native of Montebello, CA she resides in Los Angeles, CA.

To begin the appointment process, please review, sign and return the enclosed Remuneration Form, Undated Separation Forms, Background Check Release and Information Sheet within one week of receiving this letter. These documents are necessary to ensuring the most efficient, open and accountable City government possible. Further, Mayor's Office policy requires you to be fingerprinted as part of the background check that is done on all potential Commissioners. To do so, please bring this letter to the Background Unit of Employment Services Division, Personnel Department Building, 700 East Temple Street, Room 235, Los Angeles, California 90012. The division phone number is (213) 473-9343. Fingerprints must be taken within three working days from the receipt of this letter.

Under separate cover you will be receiving a packet from the City Ethics Commission containing information about the City's conflict of interest laws and a copy of the State Form 700/Statement of Economic Interests. You are required to complete and return this form **within 21 days** of your nomination to the City Ethics Commission, 200 North Spring Street, City Hall, 24th Floor, Los Angeles, California 90012. As part of the City Council confirmation process, you will need to meet with Jose Huizar, your Councilmember, and Councilmember Gilbert Cedillo, the Chair of the Housing Committee, to answer any questions they may have. You will be hearing from a City Council committee clerk who will let you know when your appointment will be considered by the Housing Committee. Sometime thereafter, you will be notified by the committee clerk when your appointment will be presented to the full City Council for confirmation. Once you are confirmed, you will be required to take the oath of office in the City Clerk's Office in Room 395 of City Hall. Claudia Luna will assist you during the confirmation process if you have questions.

Commissioners must be residents of the City of Los Angeles. If you move at any point during your term, have any changes in your telephone numbers, or in the future plan to resign (resignation must be put in writing), please contact my office immediately.

Congratulations and thank you for agreeing to serve the people of Los Angeles.
